# 3. SRA Submission on Kilkenny LECP

#### 4. Draft Planning and Development Bill

Kevin Lynch and David Kelly briefed the Members on the Draft Planning and Development Bill, highlighting the key concerns of the Regional Assembly. A discussion followed with contributions from Cllr. Boyle, Cllr. Sheahan, Cllr. Murnane, Cllr. Kelly, Cllr. O'Shea, Cllr. Breen and Cllr. McCarthy. Points arising included:

 Cllr. McCarthy proposed a workshop on the Draft Planning and Development Bill for the Members, as soon as possible, with a representative from the Department of Housing, Local Government and Heritage in attendance.

#### 5. Proposal for Members Trip to Brussels

David Kelly presented a proposal for a small delegation of Members to travel to Brussels in June or July to gain a deeper understanding of how their roles as Assembly Members intersect with the role of the European Commission. It was proposed to draw up a list of Members who previously made trips to Brussels in 2019 and 2022, and Members were asked to revert with nominations.

A discussion followed with contributions from Cllr. Sheahan, Cllr. Breen, Cllr. McCarthy, Cllr. O'Callaghan, Cllr. O'Shea and Cllr. Phelan. Points arising included:

- It was proposed to have two trips to Brussels, one in June and second in October, with seven or more Members.
- It was agreed that the Director would discuss the logistics with IREO and come back with options.
