1. Adoption of Minutes of Meeting held on 13th May

2. Matters Arising

Cllr. Boyle requested the consultation on the future of rail transport as part of an All-Island Strategic Rail Review be discussed at a future Regional Assembly meeting. Cllr. Michael O'Meara seconded Cllr. Boyle's request.

3. 'The 21st Century Councillor in Irish Local Government'- Dr. Brendan O'Keeffe, The International Centre for Local and Regional Development (ICLRD)

Dr. Brendan O'Keeffe of the ICLRD gave a presentation (copy available) on The 21st Century Councillor in Irish Local Government. A discussion followed with contributions from the Cathaoirleach, Cllr. Carroll, Cllr. Forde, Cllr. Kelly, Cllr. Sheahan, Cllr. Boyle and Cllr. Kelleher.

Key issues discussed included:

- A need to engage and attract younger people to choose a role in local politics;
- The diminishing powers and rights of a councillor;
- The AILG questionnaire is too time consuming for councillors to complete;
- A need to follow through on the councillors' questionnaire feedback.

4. EMPOWER Project - Energy Poverty Good Practice Guidebook - Colin Simpson, 3CEA

Rose Power introduced Colin Simpson, Consultant with 3CEA who presented their Energy Poverty Good Practice Guidebook for the Southern Region. A discussion followed with contributions from the Cathaoirleach, Cllr. Boyle and Cllr. Kinsella.

Key issues discussed included:

- A need for local authorities to retrofit old houses;
- A need for to promote all retrofit schemes/options to raise public awareness;
- A need to instruct the public on how to use their energy efficiently.

The Cathaoirleach stated a training workshop for Members will be organised in the coming months.
