1. Adoption of Minutes of Meeting held on 12th May

The Members adopted the minutes of the meeting held on 12th May, proposed by Cllr. O' Shea and seconded by Cllr. Carroll.

2. Matters Arising

3. EU Competitiveness Index – Helen Leahy, Head of Regional Policy, IBEC

David Kelly introduced Helen Leahy from IBEC to give a presentation on the EU Competitiveness Index, and the role of IBEC in the Southern Region.

A discussion followed with contributions from Cllr. Boyle, Cllr. O' Callaghan, Cllr. Carroll, Cllr. McGuiness, Cllr. Kinsella, Cllr. Murphy, and Cllr. Kelleher.

Points addressed included:

- Capacity constraints in relation to Infrastructure, Housing, Public Services and Education
- Investment in SETU driving innovation and connectivity in the Southern Region
- Increasing of activities in low scoring Regions, e.g., Work from Home initiatives, and enticing larger Businesses to invest these areas

David Kelly highlighted the link between the lack of investment in Lifelong Learning in the Southern Region, and how the 'Towards a Learning Region' report is looking to address this deficit. One key development is that an application has been made for Waterford City to become part of the UNESCO Global Network of Learning Cities.

4. Adoption of the Annual Financial Statement 2022

The Annual Financial Statement 2022 was adopted on the proposal of Cllr. McGuinness and seconded by Cllr. Beasley.

David Kelly thanked Sharon Murray and the Finance team for their work in putting the accounts together.

5. Adoption of the Annual Report 2022

The Annual Report 2022 was adopted on the proposal of Cllr. Carroll and seconded by Cllr. O'Callaghan.

Marie Harnett gave a presentation on the Annual Report 2022, and its highlights. David Kelly said the annual report illustrates the wide array of work the Assembly is delivering on and thanked the team and Members for their input.

6. Regional Planning Update Feedback from Members Workshop on June 2nd

David Kelly gave an update on the SPA Members Workshop held in Great National Hotel, Ballykisteen, Limerick Junction, Co. Tipperary on 2nd June 2023. He noted that the event was well attended by members and by representatives from the Department of Housing Local Government & Heritage and representatives from academia.

A discussion followed with topics raised by Cllr. Kelleher, Cllr. Phelan, Cllr. Sheila O' Callaghan, Cllr. Alan O' Callaghan, Cllr. Shannon, Cllr. PJ Kelly, & Cllr. Carroll. Topics raised included:

- Consideration of Gender Balance to the composition of the Assembly
- Induction to Assembly for New Members
- When the Assembly is advertising in local media, consider naming the Assembly Members in that locality – this would raise profile of their work on behalf of the region with local constituents.
- Consideration of an Annual Members Workshop

7. Any Other Business

Cllr. Carroll raised an issue in relation to the disposal of IDA lands in Skibbereen and which he would be raising at the next County Council meeting.

In addition, Cllr. Carroll said that there should be more in-person attendees for Assembly meetings and for the Assembly should use Cork Airport for flights to Europe.

Cllr. McGuinness raised two topics, firstly the Retained Firefighters strike and how that affects local councils and work life balance of the firefighters. Secondly to call for a referendum to be held

regarding to the ownership of Uisce Éireann, and that he will be bringing a motion to the next Assembly meeting.

Kevin Lynch gave an update on Regional Planning and these included:

- The Draft Newcastle West Local Area Plan has been circulated to Members
- On Monday 12th June a Draft of the submission to the Mid-Term Review of Regional Airports Programme will be circulated to members
