# 3. The Economic Impact of Southern Region Ports – Report by Menon Consultants: Presentation and Discussion.

Introducing this item, Eoin O'Connor detailed its requirement to support ROP 145, Ports and Harbours Strategy for the Southern Region, detailing the economic impact of the port sector; direct effects in the ports; total economic impact and the wider economic benefits of ports.

Menon Consultants presented on the detailed the Potential for growth in marine economic sectors; Offshore wind; Marine tourism; Fisheries and aquaculture and Alternative fuels and renewable energy hubs.

There followed much discussion and questions from Cllrs S. O'Callaghan; Ward, Breen, Walsh and Phelan, Moriarty, Sheahan, Colleran Molloy, Coughlan and Mayor Moran. There was a request for a technical paper regarding the funding structure of ports, a round table discussion with the CEOs of the Ports, and an indication of how Members can influence political powers to invest in this sector.







Having reiterated the reason for this report, David Kelly stated its purpose was to give a good technical understanding of the current state of play in this sector and feed into future planning within the RSES.

The Leas Cathaoirleach proposed that Standing Orders be set aside for the meeting to continue past the specified time. All Members agreed.

# 4. Smart and Sustainable Mobility Accelerator Programme - Track 2: Update & Discussion.


