#### 3. Report on LECP; Tipperary and Waterford.

The **Tipperary LECP report** given by Brigh Ryan was considered by the members of the Regional Assembly where it was agreed:

- (i) the core strategy and the objectives of the Development Plan



- (ii) The Regional Spatial and Economic Strategy for the Southern Region
- (iii) between the community and economic elements of the LECP

- (i) the core strategy and the objectives of the Development Plan
- (ii) The Regional Spatial and Economic Strategy for the Southern Region
- (iii) between the community and economic elements of the LECP

#### 4. Draft Budget 2024.

The Draft Budget 2024 had been circulated with meeting documents to all Members. It was noted that there is a 9% increase, due to a number of factors, inter alia – a) Staff Numbers increase, b) consequential T&S increase c) Members T&S increase d) reduction in funding stream from the Ireland Wales Programme.

The budget was approved on the Proposal of Clir. Ken Murnane and Seconded by Clir. Robert Beasley.

#### 5. Update on ERDF Regional Programme 2021-2027.

Enda Hogan gave an update on implementation of the Southern, Eastern and Midland Regional Programme 2021-2027. - El Technology Gateways: Supporting a network of "Technology Gateways" in the Technological Universities (TUs), increasing their capacity and ability to engage with SMEs throughout the region.
- KT Boost: Supporting Irish universities and TUs to increase the level commercialisation of research and to develop consistent practices across the knowledge transfer (KT) sector.
- El Innovators Initiative: Supporting the creation of three new "immersive, needs-led innovation training programmes" modelled on the success of <u>BioInnovate</u> in Galway.
- SFI ARC Hubs: Supporting the creation of "ARC Hubs" to accelerate the commercialisation of research in thematic areas in line with S3 and drive regional economic development.
- **HEA TU RISE**: Supporting research capacity building in the Technological University Sector in line with S3.



- Smart Regions Enterprise Innovation Scheme: Supporting the regional innovation ecosystem through local infrastructure projects, innovation clusters and consortia, services to SMEs to drive innovation and Feasibility & Priming Grants.
- **SEA! Warmer HOMES** DEEP HEAT RETROFITS: Medium Depth Energy Efficiency Upgrades for Households at Risk of Energy Poverty.
- A funding call under the following scheme is close to finalisation but may slip into early 2024.
  Town Centre First Heritage Revival Fund THRIVE: Supporting the development or enhancement of Integrated Urban Strategies and funding Capital Projects (Adaptive re-use of Heritage Buildings) for Designated Settlements.

Following discussion, it was proposed by the Executive that a spokesperson from SEAI would be invited to present at the next available Assembly Meeting, this was agreed by the Members.
