# PLEASE OUTLINE ANY PROGRESS MADE IN SUPPORTING THE OBJECTIVES OF THE RSES WHICH ARE RELEVANT TO YOUR DEPARTMENT-

In framing your response please provide a short overview of key public investment mechanisms and proposals by reference to:

1. Key mechanisms the Department has put in place to ensure that investment decisions are aligned with the NPF and Southern Region RSES

Future employment growth and sustainability requires a major focus on boosting regional growth potential. This necessitates the promotion of growth that is sustainable, driven by exports, and underpinned by innovation and competitiveness across all regions.

The Department of Enterprise, Trade and Employment's (DETE) capital spending is set out at a high level as part of Project Ireland 2040. The National Strategic Outcome (NSO) of "A Strong Economy Supported by Enterprise, Innovation and Skills" drives much of the Department's activity. The National Planning Framework (NPF) aims to achieve balanced regional development, matching employment growth in the Eastern and Midland Region with that in the Northern and Western and Southern Regions.

# White Paper on Enterprise 2022-2030

This is complemented by the Department's White Paper on Enterprise 2022-2030, which identifies balanced regional economic and enterprise development as central component of our enterprise policy. To that end, the Department's enterprise development agencies, Local Enterprise Offices and Regional Enterprise Plans play a significant role in strengthening the enterprise ecosystem right across Ireland. This enables entrepreneurs, microenterprises, SMEs and FDI to prosper in all regions.

# **Smart Specialisation Strategy**

In July 2022, DETE published the National Smart Specialisation Strategy for Innovation 2022-2027 (S3). The preparation of the S3 allowed for the assessment of Ireland's regional competitive advantages, future market opportunities, solutions to societal challenges, as well as the effectiveness of the current suite of enterprise innovation supports.

Accordingly, the S3 builds on identified regional and national strengths to ensure the creation of a supportive environment for innovation to flourish, new start-ups to emerge and businesses to scale. It puts a focus on the twin green and digital transformations needed across the enterprise sector, while aligning our national innovation system to engage with this challenge. It embraces a regional approach to addressing Ireland's research, development and innovation (RD&I) challenge, providing an important 'bridge' between regional and national innovation strategy-building and decision-making.

Smart Specialisation is a key principle underpinning the European Commission's Cohesion Policy for the period 2021-2027 in the Research, Technology, Development and Innovation (RTDI) priority. The existence of an S3 is an enabling condition for EU Member States to access structural funding under the European Regional Development Fund (ERDF) in this field, the programmes for which are aligned with the Regional Spatial and Economic Strategies (RSES).

Beyond this, the Regional Enterprise Plans are driven by regional stakeholders and complement the work of the enterprise agencies in championing initiatives where a region has a competitive advantage consistent with Smart Specialisation principles.

#### **IDA** Ireland

IDA Ireland continues to progress delivery of its targets and strategic objectives as outlined in its strategy, Driving Recovery and Sustainable Growth 2021-2024, which focuses on five pillars: Growth, Transformation, Regions, Sustainability and Impact.

The national context for IDA's approach to winning investment across Ireland's regions is set by Project Ireland 2040 and the associated National Planning Framework (NPF), National Development Plan (NDP) and RSES. Its "Regions" pillar also aligns with the objectives of the Programme for Government in relation to regional

development. The overarching ambition of national policy on regions is to promote balanced, compact and sustainable growth outside of Dublin. The realisation of the strategic outcomes of the NPF, through the growth and development of regional cities and towns, would significantly enhance Ireland's value proposition to FDI and support emerging urban locations of scale to become future FDI growth drivers.

2. Progress in enhancing overall economic performance, job creation and enterprise development having regard to the Regions' Cities and economic drivers

### **SME and Entrepreneurship Growth Plan**

The SME and Entrepreneurship Taskforce Report: "National SME and Entrepreneurship Growth Plan" was published in January 2021 and an Implementation Group was established in February 2021. The Implementation Group agreed ten priority areas where significant progress could be made in the short term. An eleventh priority area around Ireland's climate ambitions was added in 2023. In 2023, the SME and Entrepreneurship Taskforce met four times to review the progress made across the following eleven priority areas:

- 1. Access to finance
- 2. Digital transformation
- 3. Increasing first-time exporters
- 4. Enhanced assistance for high-potential businesses
- 5. Clustering and networks
- 6. SME management skills
- 7. Reducing the regulatory burden on SMEs
- 8. Delivery of a single portal for business information and assistance
- 9. Ensuring comprehensive agency coverage for SMEs and
- 10. Promoting SME participation in public procurement
- 11. Ireland's climate ambitions.

To date the taskforce has presented progress reports to Government on its priorities at the end of 2022 and 2023.

#### **Enterprise Ireland**

Employment in client companies of Enterprise Ireland increased to a total of 74,428 in 2023 in the Southern Region, the highest ever recorded. The total number of jobs created was 5,022. When job losses are considered, there was a positive net jobs result of 1,551 in a very challenging year for businesses.

Just over 32%, or almost one third, of new jobs created in 2023 in companies supported by Enterprise Ireland were in the Southern Region.

Enterprise Ireland supported companies recorded jobs growth for the third year in a row. 2023 was a particularly challenging year for exporting Irish businesses with rising input costs, high interest rates and international instability among the issues that impacted business performance. Enterprise Ireland remains determined to help businesses face these challenges and continue to create high-quality employment across every region in Ireland. In addition to direct financial support, Enterprise Ireland is working to ensure an increased focus on innovation, digitalisation and sustainability so that Irish companies can continue to compete and win in global markets.

Export-focused companies are continuing to create quality employment across the Southern Region, despite a challenging business environment. Employment in companies supported by Enterprise Ireland is now at its highest ever level.

Enterprise Ireland is determined to support both the start-up sector and established companies to increase sales and exports in global markets which results in increased employment. Business sentiment among Enterprise Ireland's client companies remains very high and they are continuing to innovate to ensure they are competitive in global markets that remain turbulent.

## **Local Enterprise Offices Annual Employment Results 2023**

The results of this year's Annual Employment Survey are extremely positive, with Local Enterprise Office (LEO) client companies creating 6,640 new jobs in 2023. These new figures show a tenth consecutive year of jobs

growth since the LEOs were established in 2014. The figures show that the network of LEOs now has a portfolio of 7,167 small businesses that account for 38,726 jobs across the country.

The 38,726 jobs that have been financially supported by the LEOs is the highest number on record since the LEOs began. The figures also show that 82% of the new jobs created by LEO client companies in 2023 were outside of Dublin. When this is measured against job losses in the portfolio, this represents a net gain of 2,131 jobs across the country.

These job numbers refer only to jobs recorded by those businesses that received LEO grant aid.

Thousands more jobs are created by businesses which have received non-financial LEO supports including expert advice, one-to-one mentoring, targeted training, or supports addressing the strategic priorities of Exporting, Decarbonisation and Digital Transformation with the Green for Business, Energy Efficiency Grant, Exporter Development and Digital for Business initiatives.

#### **IDA** Ireland

The Southern Region is home to three Regional Cities: Cork, Limerick, and Waterford. IDA Ireland has Regional Development teams supporting the implementation of IDA Strategy at the regional level based in three regional offices across the Southern Region, namely Limerick, Waterford and Cork.

Over the period 2021-2024, IDA Ireland is targeting 800 client investments with 400 targeted for regions outside Dublin (50%). IDA Ireland has also published investment targets for every region over the four years of its current strategy. The combined target for the Southern Region over the period 2021-2024 is 234 investments.

#### FDI Base in the Southern Region

There are 478 IDA client operations in the Southern Region employing 93,854 directly in 2023. This represents 31% of total IDA client employment nationally. Including indirect employment estimated at 75,084 supported by FDI, the total number of jobs supported both directly and indirectly by FDI in the Southern Region is estimated at 168,938 jobs.

## FDI Economic Impact in the Region

The impact of FDI across the Southern Region is significant with an estimated €9.97bn spend in 2022 which is an increase of 9% on 2021. The 2022 spend is comprised of Payroll €6.48bn and purchase of Irish Materials and Services. In addition, an estimated €1.5bn was invested by client companies on Inhouse R&D in 2022.

#### IDA Property

In addition to private sector property solutions, IDA Ireland has an extensive property portfolio including Strategic sites, Business and Technology Parks and buildings located across the Southern Region to support the winning of FDI. IDA Ireland also has an ambitious Property Investment programme to support the ambition of winning new FDI across the wider region. Under its current strategy, IDA Ireland has developed new Advanced Building Solutions in Carlow, Waterford and Limerick to support the winning of new client investments.

# Areas of Competitiveness for Regional Development

IDA Ireland's primary focus is to support its client companies and ensure that Ireland and its regions continue to be fit for purpose to support the continued attraction, growth, and expansion of FDI. A key ingredient of our success to date has been in ensuring that Ireland continues to provide a proactive business environment both nationally and regionally and is responsive to the needs of our client companies.

Key to our success in the past and essential to our success in the future is strategic collaboration with national and local stakeholders on the enhancement of the regional value proposition for FDI and to harness the strengths and address the weaknesses of Ireland's regions.

Several stakeholders at both local, regional, and national level have a key role to play in supporting IDA in winning FDI for Ireland and all its regions.

The delivery of necessary infrastructure, utilities and property solutions, the availability of a skilled and future ready workforce, and an emphasis on quality of life and placemaking in each region are pre-requisites to winning continued investment from MNCs.

Areas of focus for enhanced competitiveness of regional locations include:

- Talent & Skills
- Planning
- Housing
- Property Solutions
- Utilities
- Sustainable Transport
- Placemaking

The above are vital to ensure regions are attractive places to live which is the fundamental bedrock to having the talent and skills base that can subsequently enable FDI attraction. IDA Ireland, together with local authorities, academia, business associations and industry can act on placemaking to give Ireland's regions a competitive edge internationally, supporting smart-city technologies and ensuring Ireland is positioned as one of the best places in the world both to do business and to live.

#### **IDA Client Company Announcements**

A summary of IDA client company announcements across the Southern Region over the period 2021-2023 is detailed in Appendix 2. This is a sample of some, but not all, IDA Ireland client activity in the region.

# 3. Progress on delivering the Regional Enterprise Plans (REPs)

Nine Regional Enterprise Plans (REPs) to 2024 were launched in early 2022 and are now in the final year of implementation.

At a regional level, delivery of each REP is led by a Steering Committee of regional stakeholders and chaired by a senior private sector businessperson, supported by a full-time REP Programme Manager (PM).

- Mid-West Steering Committee Chair is Professor Eamonn Murphy and PM is Dr. Paraic Rattigan
- South-West Steering Committee Chair is Patricia Quane and PM is Aileen Hurley
- South-East Steering Committee Chair is Patsy Carney and (interim) PM is Richard Hickey

The role of the PM is critical to the successful implementation of the REPs as they are chiefly responsible for driving implementation and stakeholder engagement on the ground in each region.

The Department is responsible for monitoring implementation of the Plans at a national level through the National Oversight Group (NOG), chaired by the Department's Ministers. The last meeting of the NOG took place on 26 October 2023 and implementation was considered to be progressing well overall across the Southern Region.

The Regional Assembly will be familiar with the Smart Regions Enterprise Innovation Scheme (SREIS), which is co-funded under the European Regional Development Fund. This scheme supports projects aligned to the REPs. The first call of €35 million was announced in October 2023 with subsequent calls in the coming years.

Nine mid-term progress reports are currently being prepared and will include a comprehensive action-by-action update on the implementation of each of the Plans up to Q3 2023.

# 4. Progress made by the Department in developing sectoral supports

#### **Ukraine Credit Guarantee Scheme**

The Ukraine Credit Guarantee Scheme was launched on 30 January 2023, with a total available ceiling for lending of €1.2 billion. The Scheme is available to SMEs, primary producers and small mid-caps that have seen their costs increase by at least 10% since 2020 as a result of the impact of the conflict in Ukraine. Loans under the scheme range from €10,000 to €1 million and are available to eligible businesses at interest rates below market rates, with no requirement for collateral or personal guarantees for loans of up to €250,000. The Scheme will run until 31 December 2024.

These loans provide funding for working capital and medium-term investment purposes. A total of 681 loans for a value of €58 million were taken out by business in the Southern Region from the launch of the Scheme until 30 November 2023. This represents 38% of all loans drawn under the Scheme up to that point.

# **Growth and Sustainability Loan Scheme**

The €500 million Growth and Sustainability Loan Scheme launched in September 2023 provides loans between €25,000 and €3 million, with terms of up to 10 years to SMEs, including farmers and fishers and small mid-caps. The scheme will target a minimum of 30% of the lending volume towards environmental sustainability purposes with the aim of encouraging SMEs to take positive actions in support of the climate change agenda. Loans for climate action and environmental sustainability purposes will also benefit from an additional interest rate discount.

Up to 70% of lending will be for strategic investments with a view to increasing productivity and competitiveness and thus underpinning future business sustainability and growth. The Growth and Sustainability Loan Scheme will operate until 30 June 2026 or until the scheme has been fully subscribed (whichever is earlier).

#### **Smart Specialisation**

The National Smart Specialisation Strategy for Innovation 2022-2027 sets out a number of sectoral priorities which underpin ERDF programmatic investment in the region. These were derived from extensive stakeholder consultation and analysis. These sectors are:

- Financial Services/FinTech
- ICT
- Bioeconomy/Renewable Energy
- Food/Agritech
- Advanced Manufacturing
- Marine
- Biopharma/Life Sciences
- Climate Action/Sustainability
- Automotive/Aerospace
- Design
- MedTech
- Audiovisual/Creative
- Transport

#### **Construct Innovate**

On 9 December 2022, the Department (with Enterprise Ireland) launched Construct Innovate, a construction-specific and industry-led research and development centre, which represents the latest addition to the joint Enterprise Ireland and IDA Ireland "Technology Centre" Programme. The Centre will be focused on key industry challenges and innovation in residential construction in its first three years of operation. Construct Innovate has initial funding of €5 million over five years, and is a consortium hosted by the University of Galway that also includes Trinity College Dublin, University College Cork, and the Irish Green Building Council.

#### **Built to Innovate**

Under the Government's Housing for All plan, Enterprise Ireland has expanded its remit to work with the domestic housebuilding sector for the first time. Through the Built to Innovate programme, Enterprise Ireland is focused on driving productivity and innovation in housebuilding, including increased use of Modern Methods of Construction (MMC), and has opened up lean and digital grants and funding for research and innovation projects in the domestic residential construction sector (previously these were only made available to exporting firms).

#### **Digital Transition Fund**

To boost the uptake of digital technology in enterprises Government established the Digital Transition Fund as part of Ireland's National Recovery and Resilience Plan (NRRP) in 2022. This is an €85 million multi-annual fund which will run until 2026. The Digital Transition Fund will increase digitalisation of all businesses across products, processes, supply chains and business models. This will bring about productivity gains, access to new markets, increased innovation and improved competitiveness.

This funding, managed via schemes run by Enterprise Ireland, IDA Ireland and Udarás na Gaeltachta, will help companies at all stages of their digital journey – from the early days of simply going online to digitalisation of products and business processes, to facilitating exporting and using digital technologies to develop new markets and business models. €16 million was allocated to the DTF in Budget 2023 and €10 million has provisionally been allocated for 2024, subject to approval by the Department of Public Expenditure, NDP Delivery and Reform.

#### **Green Transition Fund**

The Green Transition Fund, launched in June 2022, is also part of Ireland's NRRP and contains a range of supports for businesses to make the green transition. These range from vouchers to help companies prepare a plan for the low-carbon and resource efficient economy of the future, capital support for companies to invest in decarbonising their manufacturing processes; and grants to explore the development of new or improved products, services or processes in the areas of sustainability and decarbonisation.

Companies eligible for assistance under the Green Transition Fund are manufacturing clients, or potential clients, of Enterprise Ireland, IDA Ireland and Údarás na Gaeltachta, subject to the prevailing policies and eligibility criteria of those agencies. The LEOs also offer a variety of the supports under the fund and are crucial in accelerating the green transition in local and regional areas, especially towards locally-trading micro-firms and SMEs. Some more detail of these schemes is included in the sections below.

#### **Enterprise Ireland**

Enterprise Ireland's Strategy for 2022-2024 is titled Leading in a Changing World; Enterprise Ireland's mission, as set out at the start of 2022, is to accelerate the development of world-class Irish companies to achieve leading positions in global markets. El also works with the network of 31 Local Enterprise Offices through the Centre of Excellence to support the growth of micro-enterprises across the country.

Ireland has committed to reducing emissions by 51% across all sectors of the economy by 2030 and to become climate neutral by 2050 with legally binding sectoral emissions targets established under the Climate Action and Low Carbon Development (Amendment) Act 2021.

Looking at the Enterprise Sector, Government has established a commitment to delivering a 35% reduction from on-site industrial emissions by 2030. The Climate Action Plan 2023 and the White Paper on Enterprise 2022-2030 confirm Government's commitment to supporting the decarbonisation of industry through its Agencies, including Enterprise Ireland. The White Paper on Enterprise sees Government committing to placing decarbonisation on equal footing with job creation and value creation for the enterprise agencies.

Total Enterprise Ireland client emissions in 2022 are approximately 4.4Mt CO2, this estimate includes client ETS emissions and an estimate of non-ETS client emissions. From the baseline of 2018 gross Enterprise Ireland client emissions have fluctuated within a relatively modest band, with overall emissions remaining stable.

For large emitters and companies embarking on major transformative projects Enterprise Ireland provides support through the Energy and Environmental Aid measure. This has enabled Enterprise Ireland to aid new capital projects that are designed to the highest environmental standard within EU State Aid rules.

As noted above, Enterprise Ireland also has a broad suite of practical measures under the Green Transition Fund to help small to medium sized firms to develop and fund their sustainability plans and stay competitive in the market. There are two main areas of support − firstly consultancy advice to enable planning and capacity building to begin and continue a green transition; then capital support to back projects, with up to €1 million available, to assist with carbon reduction for instance. For firms looking to exploit the opportunities of a low carbon future, EI has measures to support their research and innovation into new or improved products, services, or processes in the areas of sustainability and decarbonisation.

Sustainability can no longer be seen as a something extraneous to core business strategy. The message to all Enterprise Ireland clients is that for a business to be resilient and ready to scale, domestically and internationally, sustainability must be at the heart of a company's growth strategy. Enterprise Ireland also works closely with other agencies in the industrial development field, including colleagues in the LEOs, the Sustainable Energy Authority of Ireland (SEAI), Údaras na Gaeltachta and IDA Ireland, to ensure there is alignment between all offers to business and that clients have a clear pathway in terms of supports.

# Green supports provided by LEOs

The LEOs provide assistance to small businesses in understanding and addressing their carbon footprint through the Green for Business programme. This is an initiative from the LEOs that helps to prepare small businesses for the low-carbon, more resource-efficient economy of the future. This programme offers free advice and technical support on resource efficiency, how to better understand their carbon footprint and how to implement an environmental management system to reduce costs and lower greenhouse gas emissions.

In 2023 the Local Enterprise Offices also launched the Energy Efficiency Grant, to provide capital for businesses to invest in low carbon technologies or processes identified in a Green for Business or Green Start consultancy programme, or an SEAI Energy Audit.

The LEO LEAN for Business Programme is available to clients to help build resilience within small companies. This programme provides consultancy support with a LEAN Expert (a qualified practitioner), who will work with the company to introduce lean principles, undertake a specific cost savings project and assist the company in benchmarking its performance.

#### 5. Progress made by the Department relating to the enhancement of skills, talent and innovation.

The Department of Enterprise, Trade and Employment is aware that it is essential that the Irish enterprise base has access to an adequate pool of high quality, adaptable and flexible talent. In order to meet this demand, the Department works collaboratively with other Departments and State Agencies to build and retain a highly skilled workforce to serve the needs of the economy.

Ireland operates a sophisticated skills architecture, which includes the National Skills Council, Expert Group on Future Skills Needs and Regional Skills Fora. In working closely with enterprise, this architecture is key to identifying skills gaps across the economy, and through collaboration with education and training providers, ensuring that these skills needs are quickly addressed through the education and training system.

The Department also operates an employment permit system which is highly responsive to areas of identified skills needs and labour shortages across the economy. There is continual engagement with employers and if strong evidence is presented, the rules are adjusted to ensure that skilled people from non-EEA countries can be recruited to help address skills and labour market shortages.

On 20 December 2023, Minister Richmond announced the largest ever expansion of the employment permits system, with 32 roles becoming eligible for General Employment Permits, and an additional 11 roles becoming eligible for a Critical Skills Employment Permit. A roadmap for increasing salary thresholds for all types of employment permits was also announced.

## **Smart Specialisation**

As noted above, the National Smart Specialisation Strategy for Innovation 2022-2027 (S3) is focused on building the framework for a bottom-up and spatial approach to research and innovation in each region. To do this it focuses on areas such as innovation diffusion, international RD&I collaboration and improving the national and regional research and innovation system.

Additionally, by supporting ERDF programmes, including Technology Centres and the Innovator's initiative, S3 supports regional skills development by creating training initiatives aligned with S3's sectoral, digital and green goals.

#### **European Digital Innovation Hubs**

European Digital Innovation Hubs (EDIHs) are one-stop shops for companies and public sector organisations to access, for little or low cost, expertise, advice, and opportunities to deploy digital technologies or to test technologies before investing. One of these, ENTIRE, is based in the Southern Region, led by Tyndall National Institute Cork. Funded under Ireland's NRRP, its primary focus is to help SMEs and start-ups to become more competitive in their business/production processes using digital technologies such as Internet of Things (IoT) and sensors.

#### **Disruptive Technologies Innovation Fund and Innovation**

The Disruptive Technologies Innovation Fund (DTIF) was established in 2018 as part of the NDP and has committed to €500 million in funding over the period to 2027 for co-funded collaborative projects involving the enterprise and research sectors. DTIF projects focus on the development and deployment of disruptive technologies to deliver new solutions through investment in the development and implementation of innovative products and services that will alter markets or the way business operates.

Since 2018, the DTIF has invested €371 million in 104 collaborative disruptive innovation projects with strong commercialisation potential under the first six Calls of the Fund. Of these, 49 projects with one or more partners located in the Southern Region were awarded over €184 million. These projects cover areas such as life sciences, medical devices, ICT, artificial intelligence, manufacturing and environmental sustainability.

#### LEO training/mentoring supports

To assist the small business community in meeting the challenges of the business world, the LEOs provide a wide range of training support and mentoring tailored to meet specific business requirements.

The network of LEOs promotes local enterprise culture and entrepreneurship through initiatives such as their Start-Your-Own-Business training courses, provision of business information and advisory services, schools enterprise programmes and its Management Development programme. The management development programmes provide owners/managers with the management, leadership, business skills and knowledge to achieve sustainability and growth in their business.

Given the Department's remit, much of the material supplied in response to section two, relating to enhancing overall economic performance and job creation, is also applicable to this section. However, further relevant information is supplied below.

#### **Enterprise Ireland**

Enterprise Ireland saw exports by companies it supports increase by 19% to a record €32.1 billion in 2022. This is the highest ever level of growth for Enterprise Ireland-backed companies in export value. Growth occurred across all overseas regions and in individual industry sectors. Exports to the Eurozone increased by 28% in 2022, with

the Eurozone now representing 25% of all exports by Enterprise Ireland backed companies. Expansion in trade with the Eurozone has taken place in tandem with strong Irish exports to the UK post-Brexit:

- Exports to the UK increased by 13%, reaching €9.2 billion. The UK now accounts for 29% of all exports by Enterprise Ireland backed companies
- Exports to the Eurozone increased by 28%, reaching €7.9 billion
- Exports to North America increased by 13%, reaching €5.5 billion. North America now accounts for 17% of all exports by Enterprise Ireland backed companies
- Increases in exports were recorded across all sectors with Food and Sustainability increasing by 23%
- Technology and Services increasing by 18% and Industrial and Life Sciences increasing by 14%.

44 entities across Munster and the South-East were funded under the Regional Enterprise Development Fund (REDF) with total approved funding for projects of €41.1 million.

23 entities across Munster and the South-East were funded under the Regional Enterprise Transition Scheme (RETS) with total approved funding for projects of €2.6 million.

The Pre-Seed Start Fund (PSSF) provides up to €100,000 in the form of a Convertible Loan Note (CLN) and is open to innovative start-ups in all sectors, with a focus on manufacturing, life sciences, food, and renewables. Since it was launched in 2022 there have been 34 start-up companies supported in Munster and the South-East with €2.9 million committed to those companies.

200 senior leaders from the food sector and key industry stakeholders attended Enterprise Ireland's flagship Food Innovation Summit in May 2023 at Pairc Ui Chaoimh, Cork. The event was the first dedicated Food Innovation Summit to take place in Ireland and turned the spotlight on the innovation capability within the Irish food industry and the strength of Ireland's food research ecosystem.

FinalBend was announced as the winner of Enterprise Ireland's Student Entrepreneur of the year Award. FinalBend is an innovative, sustainable, affordable, sportswear company, based in Cork. FinalBend was founded by University College Cork student and Quercus Scholar Emma Coffey.

Sixteen companies with important capital projects in primary food plants across Munster and the South-East have been awarded funding by Enterprise Ireland. This funding was provided under the Capital Investment Scheme for the Processing and Marketing of Agriculture Products. The successful companies in the region were approved €61.4 million in support from Enterprise Ireland.

#### **Local Enterprise Offices**

Specific data relating to the uptake of individual LEO grants and supports is not currently available but will be later in February when the verification process for performance statistics is complete.

#### Microfinance Ireland

Microfinance Ireland (MFI) lends to viable microenterprises that do not meet the conventional risk criteria applied by commercial lenders. It provides loans from €2,000 to €25,000 to businesses and applies interest rate charges for its lending which are not reflective of its credit risk. MFI also provides post approval mentoring services to its borrowers through the Local Enterprise Office Network.

In October 2023 MFI launched loans for microenterprises impacted by the recent extreme weather events. This scheme is available by way of low-cost loans to small businesses that cannot get loan financing from other lenders. Loan options include cashflow loans of up to €25,000, at a fixed interest rate of 5.5% APR with up to six months' full repayment moratorium. Loans can be used for general business purposes including restocking and other business costs. Loans for capital expenditure are also available which could fund the refurbishment of premises or the replacement of equipment.

## **National Offshore Wind Industrial Strategy**

The Department is currently developing a National Offshore Wind Industrial Strategy (NOWIS) to be published in 2024, which will set out how Ireland can maximise the economic opportunity arising from the production of offshore wind energy (OWE). The Strategy's primary objectives will be to ensure that Ireland fully captures the value of the supply chain to deliver an offshore wind sector at scale, to boost Ireland's strong RD&I pedigree in the sector, and to examine the routes to market for this renewable energy.

Rural coastal communities and their hinterlands are expected to benefit from the development of an indigenous OWE industry, and the Strategy will seek to maximise that potential benefit. Throughout 2023, the Department's Offshore Wind Strategy Unit engaged in extensive stakeholder consultation to inform the development of NOWIS. Engagement has been positive and constructive across the Government system and with industry.

The ambition for 2024 is to:

- Finalise the first iteration of the overall Strategy in Q1 2024
- Align NOWIS with the Department of the Environment, Climate Action and Communication's 'Offshore Renewable Energy Future Framework Policy Statement'
- Implement actions outlined in NOWIS and pursue longer-term aspects of Strategy to the end of 2024 and beyond.

#### **LEO Policy Statement**

Work commenced in September 2023 on a LEO Policy Statement. This statement will capture the roles and responsibilities of the Local Enterprise Network and set the future strategic direction of the network to 2030, in line with the Department's White Paper on Enterprise 2022-2030. It is expected that the LEO Policy Statement will be published in May 2024.

## **National Clustering Programme**

The White Paper for Enterprise 2020-2030 recognises clustering as a key tool for achieving enterprise policy objectives, including driving innovation, attracting and embedding FDI and developing linkages between multinationals and indigenous firms. It also notes the role which clustering can play in the green and digital transitions. It proposes the establishment of a National Clustering Programme (NCP), with a target to fund five national cluster organisations by 2025, and the establishment of a central coordination entity to bring coherence to the current ad hoc landscape around clustering in Ireland.

Grant Thornton was commissioned to undertake research to develop an evidence base to support the development of a National Clustering Policy. The Grant Thornton report, published in March 2023, advises that there would be "significant merit in establishing an open and multi-layer cluster programme" which encourages collaboration between Industry, Academia and Government in a triple-helix model. The definition of clusters used was: "Clusters are geographic interactive alliances of interconnected enterprises, research centres and associated institutions in particular fields that compete, cooperate and face common challenges and opportunities".

The Department is progressing work on a multi-layer NCP in line with the Grant Thornton recommendations.

#### Stage of Project

# **Disruptive Technologies Innovation Fund**

As described above, the DTIF supports co-funded collaborative projects involving the enterprise and research sectors. DTIF projects focus on the development and deployment of innovative products and services that will alter markets or the way business operates.

A total of 14 projects with one or more partners located in the Southern Region have been awarded over €55 million in DTIF funding since 2022.

## **Regional Enterprise Innovation Scoping Scheme**

The Regional Enterprise Innovation Scoping Scheme (REISS) supports the development of potential innovative regional projects aligned with the objectives of the nine Regional Enterprise Plans. The REISS offers feasibility and priming grants to help create a strong pipeline of projects for future funding calls

### **Capital Investment Scheme Agricultural Products**

This scheme will assist companies to strengthen their operational capability and pursue product and market diversification strategies and will support the long-term future of our vital agri-food sector.

Our agri-food sector employs 165,000 people in every county in Ireland and is a key driver of local economic prosperity. Enterprise Ireland is determined to support the long-term, sustainable future of the sector as it responds to consumer demand and seeks to diversify both its products and its markets.

#### **Innovative High Potential Start Ups**

Enterprise Ireland partners with high potential start-ups (HPSUs) on their journey to international growth, offering an ecosystem of funding and support for expansion into untapped global markets. These projects must involve the resolution of some technical challenge, be non-routine, or represent a 'step-up' for the company in terms of the level of RD&I capability. Applicants must be able to show adequate cash resources to implement the proposed project.

#### **Online Retail Scheme 4**

The Online Retail Scheme was created to support Irish retailers in developing a more competitive online offer, that will enable an increase in their customer base and build a more resilient business in the domestic and global marketplace both online and offline. Successful applicants were awarded funding to support a maximum grant of €25,000 (up to 50% of the projects eligible costs of €50,000)

#### **R&D Fund**

R&D drives economic growth and progress, spurs innovation and is critical for companies to stay competitive. With R&D funding, Enterprise Ireland supports innovation that helps to grow sales and employment for Irish business. The project must involve the resolution of some technical challenge, be non-routine or represent a 'step-up' for the company in terms of the level of RD&I capability. Applicants must be able to show adequate cash resources to implement the proposed project.

# Regional Enterprise Development Fund 2017-2020

The Department has, through Enterprise Ireland, provided funding to assist regions to support enterprise activity, promote regional growth and create jobs. These funds enable significant collaborative and innovative regional projects and complement the Regional Enterprise Plans where they have served as an enabler for projects emerging from that regional collaborative process.
