3. Shannon Foynes Port & The Development of the Port Sector in Ireland / Southern Region. Due to the unavailability of the arranged speaker, this item has been deferred to early 2024.

4. SEAI: Update on retrofit schemes.

The speaker, Ms Helen William, Programme Manager, gave a detailed presentation, on SEAI's "One Stop Shop" initiative but also including: Creating a Cleaner Energy Future, Home Heat Loss and Energy Use, Compare your Home Energy Upgrade Options; Free Energy Upgrade; One Stop Shop





Service; Individual Energy Upgrades, Home Energy Upgrade Grants. One Stop Shop Service, One Stop Shop: steps for homeowner, Average costs and grants, Applications by region, OSS Applications and Completions by county (Southern).

Whilst the Members thanked Ms Williams for her presentation, many expressed the view that most of the retrofit schemes are beyond the means of a lot of people and other initiatives will be necessary. Ms Williams outlined the policy reasons for the approach taken.

5. Regional Planning Update.

Assistant Director Kevin Lynch gave a update on:

- Tipperary Material Alterations re Clonmel, Nenagh and Thurles. Draft submission to be circulated to members.
- The NPF review is underway, and a draft will be published in the new year. The Regional Assembly will make a statutory submission on this.
- The New Planning and Development Bill has been published. The Assembly will make a submission on this, and a briefing will be provided to members at the January meeting.
- Two Year Report on RSES: Statutory letters have been issued to Local Authorities and briefing workshop will be held prior to Christmas. Letters will also be issued to Public Bodies advising them of their requirements to make a submission to the Assembly on the process.

6. Meeting Schedule 2024 – for approval.

The proposed meeting schedule was approved on the Proposal of Clir. Joe Carroll and seconded by Clir. Garrett Kelleher.

7. Any Other Business.

- The executive is investigating an upgrade to the I.T. system for the Chamber to better accommodate remote meetings with the changing technologies.

 the meeting will be recorded.

- Members were advised that the post of Senior Staff Officer Corporate Affairs was advertised on the 8th of December as Marie Harnett was successful in gaining the post of Administrative Officer with the Assembly. Ms. Breda Curran will be Acting Senior Staff Officer until the post has been filled. Both the Executive and Members congratulated Ms. Harnett on her success and sincerely thanked her for her unwavering assistance over the last number of years.
