3. Upscaling a Biomethane Industry in Ireland – Policy Context - Redmond McEvoy, Assistant Principal, Climate Change and Bioenergy Policy Division, DAFM.

Under the agenda item of "What is Anaerobic Digestion, Biomethane in the EU, Biomethane in Ireland", Irish Policy context, The scale of the Biomethane Ambition, Ireland's National Biomethane Strategy, Strategy development, Stakeholder Consultation, Next steps for delivery, Mr. Redmond gave a full and detailed presentation.



Include the Strategic Employment Locations of: Carrigtwohill, Little Island, Ringaskiddy and Whitegate on the Labour Force 2022 diagram.

HLG 1 should be strengthened by: referencing in the Policy Section that it is an ambition of the RSES to be one of the Europe's most Creative and Innovative, Greenest and Liveable Regions, including support for the growth of the Metropolitan Area, designated Key Towns and settlements in accordance with the RSES and County Development Plan in the Objectives Section, and referencing support for the implementation of CMATS under the Actions section for the Objective to, "Support and promote initiatives and projects which improve access to public transport for rural and urban areas, including enhanced connectivity and public transport offering.", in the Draft Initial Implementation Plan.

The reference to the Learning Region under HLG 2 should be strengthened by referencing support for the development of the Southern Region as a UNESCO Learning Region, in which Co. Cork can participate to develop opportunities for life-long learning and skills development.

7. Update on NWE Interreg Programme.

Sarah Davoren gave a brief presentation on the North West Europe Programme detailing the funding of €310 million ERDF at a 60% co-financed rate available, under the theme headlines of: Climate and environment, Energy transition, Circular Economy, Innovation and resilience and Inclusive society. Applications are sought under the quadruple helix paradigm, and Members were strongly encouraged to activate their Local Authority.
