Cllr. Michael Murphy welcomed the work that is being done by the Assembly and the Irish Regions Office, He also reminded the Assembly that within the lifetime of this Assembly, Ireland will have the EU Presidency in 2027.

The Director gave a quick introduction to the discussions which are ongoing regarding Cohesion Policy post 2027 and sought approval to continue the active involvement in the debate. A Joint Position Paper from the three Regional Assemblies will be discussed in more detail at the Sept meeting.

On behalf of the Committee of the Regions Members, Cllr. Gillian Coughlan strongly encouraged further dialogue, and encouraged all Members to highlight EU membership, involvement and activities to all their Local Authorities

Cllr. Pip Breen requested that the information deficit between the Assembly and Local Authorities be addressed;

Cllr. Ben Ward highlighted the bureaucratic burden on those attempting to access grants and requested that this be highlighted in future discussions.
