	Tralee:
	URDF, Tralee, Regional Economic Driver and Destination Town: The aim is to regenerate Tralee as a regional economic driver through boosting the supply of high-quality employment spaces, residential opportunities and the development of an excellent quality environment, by means of strategic investment in office development, public realm improvements, leisure and amenity areas.
	Following a three-month consultation period and 800 submissions, a Masterplan was prepared and adopted by the Members of Tralee Municipal District which provides for a new linear park and the development of four individual investment sites surrounding the park. The linear public realm space is now complete, the Court Service will occupy one of the adjoining development sites alongside a social housing 27-unit apartment development, an office building, and a community space.
	Island of Geese : The Island of Geese Project is a Designated Urban Centre Grant Scheme under the Regional Operational Programme 2014–2020 and is funded by the European Regional Development Fund and Kerry County Council and managed by Kerry County Council in partnership with the Southern Regional Assembly.
	The ERDF 'Island of Geese (IOG)' regeneration has transformed the western end of Tralee town centre in terms of aesthetics, permeability and creating further capital opportunities for housing, retail, community, legal and amenity. The funding has enabled Kerry County Council to demolish an old derelict factory and to transform a significant brownfield site in Tralee Town Centre. A masterplan was produced and adopted for the regeneration of the area which has created a new linear park providing much improved access to the town centre and four investment ready serviced sites. The site was renamed The Island of Geese because of its historical location. The demolition of the linear park at the Island of Geese, has had a major visual impact, but it's also improved the connectivity of the town centre. The ERDF funding and the support of the Southern Regional Assembly has enabled the local authority and the community to utilise the space to offer much more in terms of public events.
	Kerry County Council are continuing to look at ways to improve the town centre, the latest of which is the addition of a new covered public amphitheater and performance space in the centre of the Island of Geese. Funding secured under URDF funding will also further improve the public realm and accessibility, through exemplar pavement and streetscape design (Pavements Phase 3 – planning secured), thus linking the IOG to The Mall (Phase 1 and 2). Additional URDF funding, will also help decrease dereliction around the site, develop strategic designs for the Town Square and Market Quarter, and invigorate the eastern end of the town through a new Development Masterplan.
	Destination Town Tralee : Tralee was identified as having the highest potential as a destination town within the county, because it possesses the greatest scope for transformative potential regarding the "key criteria" and "additional considerations" outlined in Failte Ireland's "Development Guidelines for Tourism Destination Town," This project, funded by Failte Ireland and Kerry County Council seeks to improve Tralee's visitor orientation and wayfinding infrastructure and will be completed in 2023, following extensive consultation with the Elected Members, the Tralee Chamber Alliance and other key stakeholders.

Greenway, Tralee to Fenit:

The Tralee Fenit Greenway is a railbed conversion of the Fenit branch line which runs for 14km from Tralee to the scenic coastal village and port of Fenit. The completed greenway was opened in June 2022. An interpretation Plan is currently being developed in conjunction with Failte Ireland which will further improve facilities and experience for visitors along the Greenway. Funding has also been secured from Fáilte Ireland to develop a modern outdoor changing facility, to be located at the Fenit end of the Greenway, an essential facility for the promotion of adventure tourism.

MTU, Tralee: MTU is a multi-campus technology university where a major new campus development in Tralee will see an Expansion of the North Campus and the construction of a new Science Technology Engineering and Mathematics (STEM) Building.

Kerry Technology Park adjoins the campus of MTU and is a joint enterprise and education infrastructure with over 350 employees and 40+ businesses. It encompasses the Business Innovation Centre, 50 acres of enterprise space and a range of office suites and business units. A €330million transformative expansion is planned foe Astellas Pharma at the Kerry Technology park which will result in significant employment in the area.

Killarney:

URDF, World Class Tourist Destination: The vision for Killarney is to mirror the National Park with an exceptional Urban experience that sets Killarney apart as a world class tourism destination.

Plans have been prepared to interweave the fabric of the Urban Core of Killarney seamlessly into the National Park through a series of interrelated transport and public realm improvements and a traffic management strategy that removes as far as possible transitory traffic from the urban core. These plans aim to develop Killarney Town as a world class tourist destination, seeks to expand and diversify the Town Core's offering through creating an authentic tourist experience building on and extending the existing culture and heritage of the town through the creation of Cultural and Art/Craft Quarters, creating and defining linkages between areas of historic and cultural significance and merging the National Park as part of the Town Core experience.

The vision supports universal access throughout the town core, the transition from car predominance to pedestrian priority and for providing for low carbon mobility solutions within the town core area, replicating and building upon the environmental quality of the UNESCO Biosphere of the National Park and adjoining areas.

The objectives aim to:

1. Maximise the opportunity for Killarney as a Gateway status to the Wild Atlantic Way by enshrining Killarney as a World Class tourism experience by Creation of a World Class Environment governed by the Principal of Universal Access.

2.Improve connectivity throughout the town and orientate the town to the National Park.

3. Alleviate traffic congestion by the transition to Low carbon and Sustainable Mobility Policies.

4. Develop new visitor experiences by Enhancing and Extending the "Authentic" Killarney Offer.

5.Town Centre Regeneration & Development (Áras Phádraig)

Public Realm Plans are being advanced to upgrade the town centre streets. A Masterplan has also been prepared and adopted for the Aras Phádraig site to regenerate this derelict Town Centre Site (Áras Phádraig) to provide a community centered, cultural and commercial hub including a Primary Care Facility to support the compact growth of the town and the integration of its community. It will create a public amenity space for the promotion of community and the betterment of its health and wellbeing and will enhance the Arts/Cultural Heritage Experience. Plans are being finalised to advance this project to planning approval stage in 2024.

Centre of Excellence for Tourism, Killarney

A new centre of excellence for tourism is also planned for Killarney at a key strategic site at the former Sara Lee factory in the town. The proposed new college of further education will see a derelict site in a prominent location in the town, brought back to use. This will be the town's first third level college, managed by the Kerry education and Training Board. It will cater for 4,000, 3rd Level students and provide skills and upskilling in hospitality as well as apprenticeships for construction and new energy skills.

Uisce Eireann Investment Programme Update

Kenmare WwTP Treatment Upgrade:

At construction stage, scheduled for completion in 2025.

<u>Kilcummin Sewerage Scheme</u>: A wastewater collection network project is currently being progressed to connect Kilcummin to the Killarney sewer network, and consequently Killarney Wastewater Treatment Plant (WWTP). This project is currently at construction stage.

Small Towns and Villages Growth Programme (STVGP):

Fenit WWTP is progressing through the STVGP and is at Stage 3 (Preliminary Business Case). Knightstown WWTP is also progressing through the STVGP and is at Construction.

Anightstown wwith is also progressing through the Silver and is at Construction.

Castlegregory is also progressing through the STVGP and is at Data collection & Analysis Stage, which is expected to be completed by the end of 2024 at which time Uisce Eireann will be better able to give a timescale for completion of the project.

Glenbeigh WWTP is also progressing through the STVGP and is at Data collection & Analysis Stage, which is expected to be completed by the end of 2024 at which time Uisce Eireann will be better able to give a timescale for completion of the project.

Drainage Area Plans:

General information: The Drainage Area Plans for each settlement identified below will identify the upgrades needed to the wastewater network to cater for growth and alleviate hydraulic and environmental constraints.

<u>Killarney</u> - A Drainage Area Plan (DAP) is underway for the Killarney agglomeration and is nearing completion of Stage 4 (Strategy, Optioneering and Future solutions design) scheduled for Q1 2024. <u>Tralee</u> - A Drainage Area Plan (DAP) is underway for the Tralee agglomeration and is nearing completion of Stage 4 (Strategy, Optioneering and Future solutions design) scheduled for Q2 2024. DAPs are also being finalised for <u>Listowel</u> and <u>Ballylongford</u> both of which are also nearing completion of Stage 4.

<u>Kenmare</u> - A DAP has been completed for the Kenmare agglomeration, identifying upgrade needs to cater for growth and alleviate hydraulic and environmental constraints. Based on the findings of the DAP, the terminal pumping station at <u>Cromwell's Bridge</u> is being upgraded as part of the Kenmare WWTP upgrade project. Further, the <u>Pier Road WWPS</u> is included on Uisce Éireann's WwPS Upgrade programme and is currently at detailed design stage.

Wastewater Pumping Stations

In addition to the details above for Cromwell's Bridge and Pier Road Wastewater Pumping Stations in Kenmare the following pumping station upgrades are also being progressed:

<u>Reenrusheen WwPS No. 2</u> in Caherciveen is included on the WWPS Upgrade programme and currently at detailed design.

<u>Sneem WwPS</u> is included on the WWPS Upgrade programme and currently at detailed design.

<u>Ballinskelligs WwPS</u> – On the Dungeagan/Ballinskelligs SS is included on the WwPS Upgrade programme and currently at detailed design.

Water Supply Capacity

UE is working to address drinking water supply constraints including: *Mid Kerry WRZ*

An options report is currently being prepared to investigate the most appropriate route selection to interconnect a number of different schemes to improve long term resilience and meet the projected deficit in this WRZ. An upgrade scoped to improve treatment has been advanced.

Kenmare/Kilgarvan WRZ

Project with UE IDD to complete options appraisal for the development of new raw water source. Feasible options include both GW and SW solutions. For the GW piece, SDB Programme is currently investigating GW options in the area. Desktop studies complete. Field work will commence once land access and wayleaves are agreed. If suitable GW water resources are identified, it will aid IDD to determine the preferred solution, for which a business case will then be developed. It is advised to check back with UE for further updates as 2024 progresses.

Sneem WRZ

Sneem WTP has capacity based on the demand and the capacity of the WTP. The National Water Resources Plan preferred approach for Sneem WRZ is to increase surface water abstraction and

upgrade the WTP. A feasibility study will verify these findings, and a capital project will be advanced based on the output.

Emlaghpeasta/Portmagee/Maulin WRZ

Scope development to investigate increased groundwater potential at Portmagee has recently been completed. If successful, a production well could provide additional capacity at Portmagee. A long-term deficit will be met when a feasibility study is completed and the National Water Resources Plan preferred approach to increase surface water abstraction, will be verified.

Listowel WRZ - capacity constraints exist

UE is currently investigating GW options in the area. Desktop studies complete. Field work will commence once land access and wayleaves are agreed. If suitable water resources are identified, a project will be scoped to abstract and supplement existing supply. It is advised to check back with UE for further updates as 2024 progresses.

National Water Resources Plan - Update:

Following public consultation, the National Water Resources Plan - Framework Plan was adopted in Spring 2021. This was followed by the development of four regional water resources plans to identify plan-level approaches to address the identified need in a sustainable manner. The <u>South</u> <u>West Regional Water Resources Plan</u>, which includes County Kerry, was adopted in Spring 2023 following public consultation.

SMALLER TOWNS AND VILLAGES

Kerry County Council received funding under RRDF for the following towns; Killorglin, Listowel and Cahersiveen. Some of these projects are currently at design stage and others have recently received part 8 planning and will be submitted under call 5 of the RRDF for capital funding. A summary of the projects are as follows:

RRDF – Listowel, Listowel 'Where Stories Begin' : A new Chapter in Listowel's Economic Transformation and Prosperity.

This application is for a transformative project for the North Kerry designated regional town of Listowel and specifically the rejuvenation of Listowel Town Centre. The delivery of the Listowel 'Where Stories Begin' project is a new chapter in Listowel's economic transformation and prosperity, benefitting not only the town itself but the significant rural catchment area of North Kerry. This project will revitalise the liveability and economy of Listowel Town and the rural catchment area it supports and position Listowel for future growth, which will play a significant part in attracting people to live and work in Listowel.

RRDF funding of € €729,304 secured for Listowel. Consists of 9 different projects under the umbrella of 'Where Stories Begin'.

Redevelopment of Vacant Units at Blennerville Windmill

Kerry County Council secured grant approval of €500,000 (90% rate) under the Town & Village Renewal Scheme in February 2022 for the re-purposing of disused craft workshops at the Blennerville Windmill Centre into a Community Bakery and Baking School. The project is a collaboration between the Council, Blennerville Windmill Company CLG and Kerry Education and Training Board (KETB).

Fáilte Ireland's Platforms for Growth,

Kerry County Council was successful in securing funding for Ballybunion Beach Shared Facilities Centre, Fenit Beach Shared Facility Centre and Magherabeg Shared Facilities Centre under this scheme. The funding will be used to develop water sports activity facilities which will provide a hub in each locality from where multiple water sport operators can base themselves. These bestin-class facilities will include; changing facilities, showers, toilets, secure storage and enclosed spaces for inductions to take place.

RRDF Killorglin, SMART Rural Regeneration Project.

Building on the town's undoubted strengths while seeking to mitigate its weaknesses, a Vision for the development of Killorglin was agreed with the community through a Socio-Economic Plan process. This Vision provides a focus for a progressive and vibrant Killorglin as "A Town for the Ages; representative and inclusive of all ages, boldly optimistic for its future, while being mindful of its present and honouring its past." RRDF funding was secured to support this vision of Killorglin as A Town for the Ages and are designed to provide leadership in addressing deficiencies, unlocking investment, and building confidence In Killorglin town centre.

Caherciveen, Daniel O'Connell Quarter. Capital Projects Unit / Kenmare MD

The Cahersiveen RRDF is a comprehensive response to the serious structural, economic and social challenges currently facing Cahersiveen. The Cahersiveen Town Centre Regeneration Project builds on the significant locational, environmental, historical, tourism and cultural assets and The opportunities that Cahersiveen possesses as well as the strong relationships developed with third level educational institutions. The proposal sets out a cohesive multi-faceted approach to strengthening its sense of place both for locals and visitors, while at the same time fortifying the physical, social and economic capacity of the town. This approach is based on the development of a number of transformational and inter-related urban regeneration projects which target both physical renewal, reorientation of the town towards the sea and a comprehensive rebranding of the town as a progressive innovative, creative, environmentally sensitive, culturally rich tourist, education and innovation destination.

Rural Collaboration Partnership Models

Kerry Economic Stakeholder Forum

In response to this unprecedented economic crisis, brought on by the almost complete economic shutdown of many economic areas of activity in the County, the public and private sectors in Kerry, building on existing collaborations, recognised the need for a coordinated response to support the economic recovery of the County. The Kerry Economic Stakeholder Forum was convened in April 2020 to support the economic recovery of the County in response to the COVID-19 pandemic.

RPO 48 Innovation Hubs and Centres of Excellence RPO 49 Innovation in Rural areas RPO 50 Diversification Chaired by Kerry County Council, this interagency and business response is supported by a dedicated governance structure that lead the co-ordination of COVID-19 business supports and resilience in the County. The Elected Council is represented on the Business Advisory Team by both the Mayor and the Chair of the Economic and Community Strategic Policy Committee (SPC). Council officials from the Economic Development, Local Enterprise and Tourism units of Kerry County Council provide support for these structures. The Kerry Economic Stakeholder Forum, in consultation with key stakeholders, developed an Economic Recovery Plan for County Kerry in 2021 which reflect the significant capital and programme investment that is committed from the public sector in the delivery of strategic capital infrastructural projects to support the economic recovery of the County. This plan addresses the need to build resilience and diversification into Kerry's economy to respond to the additional challenges and opportunities faced by businesses in the County. The Economic Recovery Plan is shaped and influenced by the strategic objectives of the National Planning Framework (NPF) and the Regional Spatial Economic Strategy for the Southern Region (RSES). Both the vision of the NPF and the RSES are led by the need for transformative change in a greater regional structural realignment of population and economic activity across the state and to achieve the ambitious targets set will require investment of an equally ambitious and targeted nature.

Local Community Development Committee (LCDC)

The LCDC is charged with responsibility to co-ordinate local and community development activity in the County for the purposes of reducing overlap, avoiding duplication and improving the targeting of resources. The LCDC is the contracting authority for the Social Inclusion Community Activation Programme (SICAP) where the Kerry LCDC is also the Local Action Group (LAG) and is the main approval body for the LEADER programme investing €10.2 million in Kerry between 2014-2020. In 2021, a transitionary LEADER fund in the sum of €2,090,428 was made available to the Kerry LAG with a further €929,079 in additional allocation from EURI funds. The LCDC has overseen the implementation of the Community elements of the Local economic and Community Plan (LECP). Additionally, the work undertaken by the LCDC has enhanced collaboration and is assisting in future work programme planning, this is evidenced through the progression of the delivery of actions in the Kerry Age Friendly Strategy and the Healthy Kerry Framework. Significant efficiencies have also been achieved through enhanced strategic planning and the targeting and coordination of resources. An example is the targeting of rural grants in the county including the Town and Village Renewal Schemes, CLAR, Outdoor Recreation Infrastructure Scheme and the Community Enhancement Programme. Each of the rural grants which are applied for reference key actions of the LECP and Kerry has been successful over the years in securing funding under several schemes, each of which has enhanced local walks, public realm in towns and villages, community, and outdoor facilities and amenities.

Kerry Community Response Forum

To ensure a coordinated response to support the people fleeing the war in Ukraine, a clear governance structure and high-level framework was developed in Kerry. This framework was mainly modelled on a similar approach which worked very efficiently to coordinate the response to the COVID-19 pandemic – the Community Response Forum. Building on existing structures and relationships, the Community Response forum was repurposed; ensuring a local authority led community response to the crisis. To ensure effective coordination of local health, education, social and other integration needs the Community Response Forum was strengthened to include the establishment of sub-structures which included: 4 local area response teams; A countywide coordination team; Working Groups and a HSE In reach team.

The Local Area Response Teams and the County Coordination Team have enabled all those involved at a local level to work together to support the integration of Ukrainian refugees. These structures ensure that any issues or concerns arising at a local level are elevated at a county level through the Forum, which allows for a consistent approach and response across the county. There is also a

commitment at Forum level that the agencies represented advocate issues through their national networks. The demand-led nature of the Forum requires that the model and role of the Forum is constantly evolving and requires regular reviews to meet the ongoing integration needs.

To address the integration needs a survey of the integration priorities was carried out in 2022 and a number of working groups have been established to develop integration responses such as:

Pathways to employment group; English language support group; Bereavement support group; Accommodation provider network. The model in Kerry has been recognised nationally by NOAC as a model of good practice.

Kerry's Older People Council

The objective was to develop an Over 55s Network group as a Linkage Group of Kerry PPN to enhance and support its role in policy development and the link to the Strategic Policy Committees. The consultation process in 2022 and 2023 involved online and in person consultation, a review of the Terms of Reference and consultation with Kerry PPN Secretariat. Over 60 groups are registered with Kerry PPN as an over 55 network. There will be a plenary meeting of this grouping in Q1 2024.

Older People's Convention

The National Age Friendly Older People's Convention 2023 hosted by Kerry County Council took place in Tralee on the 11th and 12th May. This event is one of Age Friendly Ireland's main national events. The theme was Reconnecting | Fáilte ar ais – Welcome back! Representatives from Older Peoples' Councils spanning across the 31 Local Authority areas attended.

Kerry Age Friendly Steering Group

The Kerry Age Friendly Steering Group is an interagency group with a focus on input and development of policy relating to people as they age.

Kerry Chamber Network

Nine Chamber Alliances have been developed throughout the County in the last five years. Information sharing sessions have been held between the Chamber Alliances and learnings have been transferred to different areas. The Chambers have been active in progressing projects with the Council in particular in relation to festivals and events, public realm enhancements and local tidy town and biodiversity initiatives.

Active Ageing Festival

Following on from a successful inaugural event in 2022, this free Active Ageing Festival is in partnership with Munster Technological University. Second Year students from the Health & Leisure Degree Programme at MTU hosted this fun, social, and informative day for older adults focusing on balance, strength and functional movement, as well as taster sessions of some of the activities Kerry Recreation & Sports Partnership host throughout the county, including: Pickleball, Bowls, Dancing, Age & Opportunity etc.

The Kerry Public Participation Network (PPN)

Kerry Public Participation Network (Kerry PPN) is an independent umbrella network of community & voluntary, environmental and social inclusion groups active within the county. Public Participation Networks (PPNs) were established by the Irish government under the Local Government (Reform) Act 2014 to be the main link through which the Local Authority connects with these groups. PPNs give members a greater say in local government decisions which affect their own communities – through the five Strategic Policy Committees, Local Community Development Committee and the Joint Policing Committee. The PPN is also developing a disability linkage group in addition to the age friendly group. Kerry PPN is governed by the Secretariat, a voluntary board elected from the Kerry PPN membership whose responsibility is to oversee the development of the network and ensure that the objectives of the PPN are carried out. The PPN in Kerry is hosted by Kerry County

Council.

Healthy Kerry

Healthy Kerry is a project of the LCDC, supported by the Community, Arts and Culture Unit and is funded by the Healthy Ireland Fund (HIF). It is a key objective in the LECP to 'develop healthy towns and communities.' Healthy Kerry provides a platform for cross-sectoral interagency work and seeks to tackle health inequalities, which has resulted in the development of Kerry's first 'Healthy Kerry Framework'.

The Healthy Kerry Framework (2021-2027) was developed in 2021 to support the implementation of the national Healthy Ireland Framework and campaigns in response to the needs of the local community over the next five years. Echoing the national Framework, the vision of the Healthy Kerry Framework is that everyone can enjoy physical and mental health and wellbeing to their full potential in a county where wellbeing is valued and supported at every level of society. Three aspects were agreed to be prioritised for a Healthy Kerry. These include building healthy communities, promoting wellbeing in the workplace (including Remote working) and supporting the implementation of national and local policies and plans in Kerry.

With support from the Healthy Ireland Fund, annual Kerry Mental Health and Wellbeing Fest is held every year to highlight World Mental Health Day on 10th October. The organising committee is a collaboration between Connecting for Life Kerry, Healthy Kerry, Kerry County Council, the HSE, NEWKD, SKDP, Kerry Mental Health Association, Jigsaw Kerry, Munster Technological University and Kerry Volunteer Centre.

The Kerry Comhairle na nÓg – Young People's Council

The Department of Children and Youth Affairs oversees Comhairle na nÓg, the delivery of which is the responsibility of each Local Authority. There are 31 Comhairlí na nÓg nationally and the aim is to ensure that the voice of young people is heard when developing policy and local services. Young people aged 12-18 are invited to participate in the Comhairle. The Steering Group in Co. Kerry is managed by the Community Department, Arts and Culture Department. Strengthening the links with schools at county level is one of the key areas that the Comhairle in Kerry wishes to develop further.

Kerry Recreation & Sports Partnership (KRSP)

The Kerry Recreation and Sports Partnership is a sub-committee of the LCDC in Kerry and is a key lead in the delivery of a number of actions in the LECP, in particular those that aim to increase participation levels in sport and physical activity in the county. The Partnership works with relevant partner organisations and NGB's to coordinate sport programmes, events and activities to increase participation levels in sport and physical activities across the five municipal districts of Kerry. It supports clubs and communities to target increased participation in conjunction with key partners with an emphasis on low participation groups and coordinates the involvement of schools to take part in programmes and events that strengthen school-club links and provide school children with opportunities to access and enjoy new sports.

Another example of collaboration was the hosting of the Kerry Club and Volunteer Fairs. The Kerry Recreation & Sports Partnership and Kerry Volunteer Centre teamed up to host a series of Club and Volunteer Fairs in 2023. The Club and Volunteer Fairs celebrated and promoted the extensive range of fantastic local community not-for-profit clubs and organisations throughout Kerry. The events were free to attend and enabled members of the public come and see what is available for them in their community and to speak and engage with the clubs and organisations directly.

• Delivery of LECP 2016-2022

The Local Economic and Community Plan 2016-2022 (LECP) sets out the actions and objectives needed to promote, support and strengthen the sustainable development of the economy and communities of Kerry. It promotes a coordinated inter-agency approach to tackling key economic and social concerns which have been identified through in-depth research and an extensive consultation process. The economic elements of the LECP are overseen by the Strategic Policy Committee (SPC) for Economic Development, Enterprise and Planning. The community elements of the LECP are overseen by the Local Community Development Committee (LCDC).

The LECP contains the following three elements:

- Economic Development and Job Creation,
- Quality of Life
- Community and Social Inclusion

The LECP Monitoring group, an internal monitoring group of senior staff in the council has been established under the Directorate of Economic and Community Development to review the LECP and completion of actions, feedback will be provided to the Strategic Forums for discussion. To date, the LECP has largely been delivered with several high-level collaborative actions and transformational projects progressed and completed across the County.

Like all rural counties there have been significant social and economic challenges facing the county and its population over many decades. Despite these challenges there is an entrepreneurial spirit and drive within the County that has resulted in significant indigenous industries being established which have become global leaders in innovation and research. Kerry County Council has strategically invested in this research in developing the economic reputation of the County in collaboration with Higher Education, the private sector and the community. The engagement with communities in respect of several enhancement projects has enriched communities and individuals involved. There exists, because of these processes, willing community groups and sectoral representative organisations eager to build upon existing achievements, and collaboratively assist the Council in the delivery of additional projects. The Implementing Partners have prioritised the allocation of existing resources and targeted additional resources to ensure the actions agreed in the LECP are delivered. Significant financial and human resources are committed to the delivery of the LECP. Funding has been secured through Enterprise Ireland, Fáilte Ireland, the Town and Village Renewal Scheme, LEADER, CLÁR, the Outdoor Recreation Fund and the Community Enhancement Scheme to implement actions in the Plan. The LECP has set the foundation for community and economic innovation and regeneration, where the Council will work with the implementation partners to ensure all grant opportunities are maximised.

Preparation of LECP 2023 – 2029

Preparation of the new LECP is in progress. Draft High-Level Goals and Objectives have been developed with the LECP Advisory Group. Targeted stakeholder consultation has taken place and public consultation is scheduled to take place in early February.

Facilitate delivery of South-West Regional Enterprise Plan 2021 - 2024 - ongoing

The Council has provided strategic input to the current Regional Enterprise Plan and ensured actions are aligned with the LECP deliverables. A programme manager was appointed to oversee the coordination and implementation of the Plan. The consultation process to develop the SW REP was enhanced by an understanding among stakeholders of the importance of ownership, collaboration and the definition and delivery of specific measurable actions that could add value to the existing activities being undertaken by the Enterprise agencies, LEO's, Local Authorities and other relevant bodies involved in supporting enterprise development. A Regional Enterprise Steering Group overs sees the implementation of the REP. The Steering Group meets regularly and is provided updates on progress of actions by the Programme Manager. There are 6 Working Groups supporting the 6 Strategic Objectives. Kerry County Council is represented in all 6 working groups. Regular progress reports are provided to the Department of Enterprise. The following is a summary of the high-level achievements to date:

- A Clusters Managers Forum has been set up and all Clusters in the South West Region are engaged and driving forward with collaborations on projects into 2024;
- The iEd Hub is a new HCl funded collaborative initiative involving UCC, MTU and industry stakeholders providing training for unmet industry needs through a range of new post graduate courses.
- The Agri-tech cluster/ACE and VistaMilk have collaborated on one completed and further planned projects including an MOU between Teagasc-MTU
- Cork and Kerry Hubs Networks have been successfully established and are working collaboratively on events and projects into 2023 and 2024.
- The Impact Hub at the Crann Centre opened in 2022 and is serving as an exemplar in inclusivity in hubs. Training is available in connection with the Rubicon/MTU and LEOs.
 - The Space Industry Cluster feasibility study has been completed and the REISS supported Re-Create Shandon Hub feasibility report has also been completed with governance in place.
- SWREP and SRA are committed to working together to progress the recommendations of the Southern Smart Region – Towards a Learning Region report.

Establishment of the Kerry Economic Stakeholder Forum

In response to this unprecedented economic crisis, brought on by the almost complete economic shutdown of many economic areas of activity in the County, the public and private sectors in Kerry, building on existing collaborations, recognised the need for a coordinated response to support the economic recovery of the County. The Kerry Economic Stakeholder Forum was convened in April 2020 to support the economic recovery of the County in response to the COVID-19 pandemic. Chaired by Kerry County Council, this interagency and business response is supported by a dedicated governance structure that led the co-ordination of COVID-19 business supports and resilience in the County. The Elected Council is represented on the Business Advisory Team by both the Mayor and the Chair of the Economic and Community Strategic Policy Committee (SPC). Council officials from the Economic Development, Local Enterprise and Tourism units of Kerry County Council provide support for these structures.

	The Kerry Economic Stakeholder Forum, in consultation with key stakeholders, developed an Economic Recovery Plan for County Kerry in 2021 which reflect the significant capital and programme investment that is committed from the public sector in the delivery of strategic capital infrastructural projects to support the economic recovery of the County. This plan addresses the need to build resilience and diversification into Kerry's economy to respond to the additional challenges and opportunities faced by businesses in the County. The Economic Recovery Plan is shaped and influenced by the strategic objectives of the National Planning Framework (NPF) and the Regional Spatial Economic Strategy for the Southern Region (RSES). Both the vision of the NPF and the RSES are led by the need for transformative change in a greater regional structural realignment of population and economic activity across the state and to achieve the ambitious targets set will require investment of an equally ambitious and targeted nature. The Economic Recovery Plan is also aligned with national, regional and local policy and plans, including the recently published National Economic Recovery Plan, which sets out a high-level framework setting out the Government's priorities for a jobs-led sustainable and inclusive recovery; and the Government's blueprint for a post-COVID-19 recovery and development of rural Ireland over the next five years. The Economic Recovery Plan will form the basis for the new LECP 2023-2029.

	A new Kerry brand and webportal was launched on the 25 th January 2024. <u>DiscoverKerry.com</u> is the online home for the new place brand, serving as the go-to resource for a wide audience.
	The Kerry brand and website forms part of an overall strategy to promote Kerry as a place to visit, live, work and invest. The brand guidelines outline a comprehensive new messaging framework and narrative, to aid marketing activities and promote Kerry as a destination to live, work and visit.
	The Marketing Kerry partnership formed between Kerry County Council, KerrySciTech and Kerry Tourism Industry Federation has led to the development of the new place brand for the region. Through this collaboration across public and private sectors, many key stakeholders and volunteers from the region and beyond were engaged in the brand creation. These include representatives from diaspora, local and national government agencies, the tourism sector and the enterprise sector including start-ups, SMEs, large corporations, digital hubs, education, local chambers and community organisations.
	Kingdom of Kerry Greenways/walkways/trails The Kingdom of Kerry Greenways were launched in 2022 and the promotion and development of these important tourism attractors was a key undertaking in 2023. As well as marketing and promotion, Kerry County Council commissioned two reports – on the biodiversity and history/cultural aspects of the Greenways which are an essential input to the interpretation plan for the Greenways, which is being carried out by Fáilte Ireland. These Greenways are the first in a series of Greenways planned in Kerry over the coming years. They provide safe, clean, accessible and sustainable experience for users of all abilities. The Greenways are an important resource for local people and are proving to be a key driver of regional, national and international tourists to Kerry. They provide an important additional tourism product for the county.

Ongoing investment in the County's recreational infrastructure and the development of new walks and trails will be advanced in 2024 under the Outdoor Recreation Infrastructure Scheme (ORIS) and CLÁR to ensure standards are retained and new trails are advanced. The unit will also continue to promote and develop visitor resources such as the Kerry Trails Maps, Activity Brochure and other similar initiatives.

Adventure Activity Tourism

The Adventure Activity tourism sector has huge potential countywide in Kerry with numerous opportunities for hiking, walking, biking kayaking, surfing, and other outdoor water-based activities. The significant increase in outdoor activities is expected to grow year on year and not just during the summer months. Some of the initiatives currently underway include developing shared beach facilities for water sport activities at Fenit, Ballybunion and Maharabeg to enhance the visitor experience. Kerry County Council secured funding under Fáilte Ireland's Platforms for Growth programme to develop the facilities. They will include all weather changing rooms, hot showers, secure storage, equipment cleaning and toilet facilities and will be fully accessible. The centres will be built using sustainability best practices, such as solar heating panels. They will support the local economy and the outdoor activity sector by significantly enhancing the overall visitor experiences. They will assist in providing new business opportunities in local communities and support the extension of the tourism season beyond the traditional summer months. The development of these projects will commence in 2024.

Bray Head Signature Discovery Point

Kerry County Council in collaboration with Fáilte Ireland will focus on developing a Wild Atlantic Way Signature Discovery Point and enhanced visitor experiences at Bray Head. The works to stabilise and conserve the existing Signal Tower building will result in the provision of a new roof top viewing platform which will afford stunning views of the Skellig Islands and surrounding landscape. Bray Head is the closest land point to Skellig Michael and has dramatic sea views. It is one of 188 current Discovery Points along the Wild Atlantic Way.

UNESCO World Heritage Sites

The potential of UNESCO designations in the county is a key priority for 2024 with the inclusion of the alentia Trans-Atlantic Cable Station on Ireland's Tentative List as a UNESCO World Heritage Site. It is over ten years since the list has been updated and Valentia is only one of three heritage sites to be selected. Valentia and its partner station in Hearts Content, Newfoundland, will be progressed as a trans-national or joint application to UNESCO, Paris in 2024.

Kerry County Council will also continue to promote the Kerry Biosphere Reserve, Killarney and Skellig Michael UNESCO World Heritage Sites.

Film and Festival Development

Film and festival development are an integral part of our economic and tourism offering and afford an opportunity for local people to promote their areas and attract increased visitors and revenue into their community. Community Groups, Chambers and Tourism Alliances around the county make a great contribution to Kerry tourism by organising festivals and events that showcase culture, people, and places. The tourism unit will continue to support the county's wide range of festivals and events with mentoring and workshops for festival providers and marketing and promotion supports (e.g. events calendar and social media). Kerry County Council will also assist in the development of off-peak festivals to extend the tourism season, where particular emphasis will be on greening festivals in 2024.

Film development and production also has the potential not only to showcase the County internationally but also to generate jobs, revenue, and related infrastructure development, providing a boost to the local creative economy. The Council will work with agencies and key stakeholders to promote Kerry as a location for film and to advance Kerry's competitive positioning for film/tv and screen content during 2024.

Some additional examples of Tourism projects include:

- Redevelopment of Blennerville Windmill. The project will involve the redevelopment of currently derelict buildings adjoining the Blennerville Windmill in Tralee.
- Navilens Project Greenways DCEDIY Installation of Navilens signage on the Greenways to support way finding and provision of interpretation information to the visually impaired. Project partially completed in 2023.
- Greenway Furniture & Marketing- Marketing of North Kerry Greenways, purchase of street furniture and development of a biodiversity trail. Project completed January 2024.
- Greenway Website/Content Pool Kingdom of Kerry Greenways Development of Greenway Website and develop a content pool. Project completed January 2024.
- Fenit Beach Shared Facility Centre, Fenit Development of a water sports activity facility to include; changing facilities, showers, toilets, secure storage and enclosed spaces for inductions to take place. Project under way.
- Magherabeg Shared Facilities Centre, Castlegregory Development of a water sports activity facility to include; changing facilities, showers, toilets, secure storage and enclosed spaces for inductions to take place. Project under way.
- Ballybunion Beach Shared Facilities Centre, Development of a water sports activity facility to include; changing facilities, showers, toilets, secure storage and enclosed spaces for inductions to take place. Project under way.
- Ballybunion Beach Project Development Measure to progress Universal access to Ballybunion beaches. Project underway.
- Destination Town Tralee Provision of Way Finding Signage and Interpretation in Tralee. Project underway.
- Four Points of Ireland Project to market four extreme points of Ireland as a new tourism product. Feasibility study and typographical surveys completed in 2023.
- Project Development Measure Sustainable Outdoor Recreation Visitor and Community Mobility Management Plan for Valentia.
- Global Irish Festival Series An Turas Mór Festival to attract Kerry's Diaspora home from October 18th to November 1st.
- Féile Thrá Lí Five day street festival coinciding with the International Rose of Tralee.
- Supports are also provided to a number of initiatives through the Creative Ireland including Festivals, Culture Night and Crinniú na Nóg,
- The LIVE project, set up to promote the natural and cultural assets of the Iveragh Peninsula to create opportunities for sustainable tourism concluded in 2023. It was a collaboration between partners in south-west Ireland and North Wales.

It is an Objective of the Kerry County Development Plan 2022 – 2028 to reserve at a minimum 66% of completed residential units on Residentially zoned land in all Gaeltacht areas for Irish speakers. A language enurement condition (25 years) is imposed on such decisions to grant reserving 66% of the completed units for Irish speakers to be implemented by way of a section 47 agreement. The Section 47 Agreement must identify the specific dwellings reserved for Irish Speakers. The Standard of Irish required is determined and assessed by Kerry County Council by way of interview. Kerry County Development Plan 2022 – 2028 has identified 4 (No.) settlements (2 in the Corca Dhuibhne and 2 in the Uibh Rathaigh Gaeltacht areas) where small-scale clusters of housing served by their own wastewater treatment system may be permitted for local people.

	Under the Gaeltacht Act 2012, Caherciveen has been designated as a town which could be recognised as a Gaeltacht service town by agreeing a language plan with the community and for that plan to be approved by the Minister for the Gaeltacht. A Gaeltacht service town is a town situated in or adjacent to a Gaeltacht Language Planning area and which plays a significant role in the provision of public services, recreational, social and commercial facilities for that area. In 2019 Kerry County Council was appointed as the lead organisation of the language planning process. Cathair Saidhbhín Le Gaeilge was established to put the plan together in partnership with Kerry County Council. The plan has been approved by the Minister for the Gaeltacht, in 2023 and the implementation of the plan, will commence following the appointment of a Language

Planning Co-ordinator for the project in early 2024. This language plan will be implemented over a period of seven years. Above all else, this language plan belongs to the community and there will be continuous opportunities for the community to have input into the plan and to make recommendations. This is a purposeful, pragmatic plan which is focused on having more of the Irish language seen and heard in Cahersiveen in the coming years.
