	Thurles & Environs Local Area Plan 2024-2030 - this is currently at Material Amendments Stage and is due to be made in February 2024.
	Roscrea Local Area Plan 2023-2029 – this was made on the 11 th September 2023 and came into effect from 23 rd October 2023. The Roscrea Town Centre First Plan was developed in tandem with the LAP and is placed on a statutory footing by way of its inclusion within the LAP.
	Masterplans are in place for areas within Clonmel (Ballingarrane), Nenagh (Martyr's Road), Thurles (Thurles Town Centre Renewal Strategy) and Roscrea (Gantly Road) and are given statutory effect by the inclusion of objectives within the relevant LAPs. These masterplans are at various stages of implementation.
	Local Area Plans for Cashel, Carrick-on-Suir, Templemore and Tipperary Town are due to commence in 2024. Tipperary Town was the pilot town for the development of Town teams, and Town Centre Health checks in association with the methodology developed by Heritage Ireland.
	A Masterplan for Lisheen BioEconomy Campus is to be published in March / April 2024 to support the redevelopment of this area, an area included within the Tipperary Decarbonisation Zone (DZ).

	RPO 17 Clonmel The Clonmel & Environs Local Area Plan 2024-2030 (LAP) is currently at Material Amendments Stage and is due to be adopted in February 2024. A Local Transport Plan has been prepared for Clonmel, which forms an appendix to the Draft LAP. The LAP recognises the importance of Clonmel as a self- sustaining regional driver of the economy and the adoption of the LAP will place will place the Plan and the LTP on a statutory footing. In addition, a 'Town Centre First Clonmel: Action Plan' was adopted by the elected members of the Clonmel MD in December 2022, with a number of the measures included within this Plan incorporated into the LAP.
	The Clonmel 2030 Transformational Regeneration project includes four intrinsically linked and integrated pillars, namely: Kickham Barracks Regeneration, Clonmel Regional Sports Hub, Clonmel – Flights of Discovery and Clonmel Public Realm Enhancement is ongoing. Kickham Barracks Regeneration Phase 1 and Clonmel Regional Sports Hub are completed.
	The Council continues to work with TUS and the ETB to deliver a co-located third and further education campus facility on Kickham Barracks, Clonmel. The ETB are already fully located on the site. The Council shall facilitate TUS Clonmel to re-locate from their current location on Frank Drohan Road to the new co-located campus facility in Kickham Barracks (Objective 5E of the Draft Clonmel & Environs LAP 2024-2030).

The Council continues to work in partnership with larnród Éireann/Irish Rail to seek the improvement and enhancement of rail services on the Limerick to Waterford and Limerick to Ballybrophy Railway lines and deliver their strategic programme of planning and investment. The Council was fully engaged in the development of the new town bus route in Clonmel.

RPO 20 Nenagh

The Nenagh & Environs Local Area Plan 2024-2030 is currently at Material Amendments Stage and is due to be adopted in February 2024. A Local Transport Plan has been prepared for Nenagh, which forms an appendix to the Draft LAP. The LAP recognises the importance of Nenagh as a significant employment location, a county town and the major synergies with the Limerick MASP area. The adoption of the LAP will place will place the Plan and the LTP on a statutory footing.

Uisce Eireann have made a commitment to the upgrading of the wastewater treatment plant for Nenagh to support new development in the town. A planning application is expected to be submitted for these upgrade works in the first half of 2024.

Detailed design is completed and advance work including fencing and site clearance work is expected to commence in Q1 2024 on the R498 (Nenagh to Thurles Road). It is anticipated that a Contractor will be appointed and works commencing in Q3 2024.

It is proposed to develop a transport hub at the rail station in Nenagh with inter-urban bus services and cycle storage facilities and to provide an improved rail service to meet the needs of the community, in consultation with the NTA and Irish Rail. Policy support is provided under the Draft LAP and LTP and active discussions on this project are on-going with the NTA.

A Centre of Excellence for Sustainable Energy is being developed for Nenagh, to be the anchor and catalyst for the redevelopment of Martyr's Road Regeneration Quarter. Funding has been approved and the delivery and implementation of this project is ongoing. The procurement of this project is now progressing to detailed design stage with tender publications expected imminently.

The Council continues to work in partnership with larnród Éireann/Irish Rail to seek the improvement and enhancement of rail services on the Limerick to Waterford and Limerick to Ballybrophy Railway lines and deliver their strategic programme of planning and investment.

RPO 21 Thurles

The Thurles & Environs Local Area Plan 2024-2030 is currently at Material Amendments Stage and is due to be adopted in February 2024. A Local Transport Plan has been prepared for Thurles, which forms an appendix to the Draft LAP. The LAP recognises the importance of Thurles as a town with significant employment potential, as well as regional and inter-regional connectivity. The adoption of the LAP will place will place the Plan and the LTP on a statutory footing.

As detailed below, significant progress has been advanced in the development of the Lisheen National BioEconomy Campus, with discussions ongoing with funding bodies, land owners, prospective developers and the development of a Masterplan for the site.

Thurles continues to be a hub of national sporting activity, hosting intercounty and Munster championship games and finals. Planning permission was recently granted for the development of a Regional Sports Campus at Technological University Shannon, Thurles. The Council will continue to support TUS through continued collaboration with the project stakeholders and to seek funding opportunities for its delivery through the Large-Scale Sports Infrastructure Fund (or other means).

The Council supports the development of a multi-modal public transport hub at Thurles Train Station in conjunction with the NTA and Irish Rail. Policy support is provided under the Draft LAP and LTP.

The Liberty Square Enhancement Scheme seeks to deliver a vibrant Liberty Square at the heart of Thurles. The revitalised Liberty Square will become an engine for growth in and around Liberty Square and will enhance the attractiveness of Thurles as a place to live and a place for investment /

The 2022-2026 Housing Construction programme include a programme of works for 50 different construction projects, varying in scale from 1 to 67 units, including turnkey developments and AHB programmes. Notable recently completed developments at Stanwix Village in Thurles, Glenconnor in Clonmel, and Newport, Portroe, Bansha and Ardfinnan.

The Council have strong working relationships with statutory infrastructure providers such as Uisce Éireann and engage proactively in consultations such as the 'Uisce Eireann Draft Regional Water Resources Plan' and 'Uisce Eireann Stage 2 Investment Plan 2025 to 2029'. Nonetheless, the pace of delivery of waste water capital infrastructure projects has had implications on the delivery of new homes and services in some towns, including Ballina, Fethard and Kilsheelan. Other critical issues in relation to the development of key regeneration sites relate primarily to construction cost inflation, and securing adequate resources to project manage projects.

The following provides a list of specific projects being undertaken by the Council:

Clonmel 2030 Transformational Regeneration - The project includes four intrinsically linked and integrated pillars including Clonmel Public Realm Enhancement. Total project costs approved are €15,163,247 and URDF grant awarded is €10,594,961. As outlined above, a number of projects for Clonmel have already been implemented.

Nenagh Historic and Cultural Quarter – This comprises a Plan to regenerate specific existing buildings and civic spaces of distinction and value within Nenagh (including The Gaol, The Castle and Banba Square). Funding was approved in 2020 under the Rural Regeneration Development Fund. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs approved are €896,712 and RRDF grant amounts to €672,534. A funding application for capital funds for this project will be submitted through the RRDF in February 2024.

A Centre of Excellence for Sustainable Energy, Nenagh - The proposal is to develop a Centre of Excellence for Sustainable Energy, to be the anchor and catalyst for the redevelopment of Martyr's Road Regeneration Quarter, a 10 ha. strategic site of brownfield lands and underutilised properties located in the heart of Nenagh Town Centre. The works to be supported also include Public Realm and Amenity Enhancement to Friar Street Civic Plaza, Martyr's Road Town Park, Martyr's Road streetscape improvements, including cycleways. Funding has been approved and the delivery and implementation of this project is ongoing. Total project costs approved are \pounds 12,700,000 and URDF grant awarded amounts to \pounds 9,525,000.

Gantly Street, Roscrea - Development of the Gantly Street masterplan area will transform a central area of Roscrea, create opportunities to provide homes, business and amenity space for local residents to enjoy and lead to knock-on socio-economic benefits for the whole of the town. The regeneration and re-imaging of Gantly Street is critical to the overall delivery of the Gantly Street Age Friendly Neighbourhood masterplan area into the future. Funding was announced by Minister Heather Humphreys under Phase 2 on 10th November, 2022. Total project costs amount to €5,639,145. RRDF grant approved is €4,511,316.

Templemore Town Hall Enterprise and Cultural Centre with Civic Plaza - The project proposal is a flagship urban regeneration project to conserve and establish Templemore Town Hall as an economic, cultural and community hub of the town, the District and the Mid-West Region. The project was prepared by the Council in partnership with Garda Training College, Templemore College of Further Education, Templemore Community Development Association, the Local Enterprise Office and the Tipperary Energy Agency. Funding was approved in 2019 under the Rural Regeneration Development Fund. Total project costs approved are €4,014,746 and RRDF grant amounts to €3,011,060. This project is now on site is expected to be completed in June 2024.

Fethard Town Park – This completed project consisted of the development of a community sport and recreational campus, incorporating a community pavilion, playing pitches, walkways, parkland and open spaces. The project was developed through a partnership approach with Coolmore Ireland, Cashel and Emly Diocese and Healthy Ireland. The official opening was in June 2023.

	Tipperary Town Regeneration - This is a significant regeneration project for Tipperary Town and includes: Upgrade of the Market Yard as a pedestrian priority area linking the Excel Heritage Centre to Market Yard and the Town Centre; Development of an 800m gravelled walkway parallel with the existing river channel and connecting to the existing path near Glenview. All elements of this project are completed.
	Thurles Liberty Square Enhancement Scheme – this scheme seeks to deliver a vibrant Liberty Square at the heart of Thurles. Phase 1 works are fully completed. The Project Management Plan for the delivery and implementation of Phase 2 of this project is ongoing. Total project costs approved are €10,700,291 and URDF grant awarded amounts to €5,390,291.
	Thurles Market Quarter – This is a collaboration between Tipperary County Council, Thurles Lion's Club and Mary Immaculate College Thurles. The project will provide a designated market space in the town centre. The project was awarded RRDF Funding in April, 2021. The Project Management Plan for the delivery and implementation of this project is ongoing. Total project costs are €3,825,700 and RRDF grant amounts to €3,443,130. Works will commence in Q1 2024 with estimated completion in Q2 2025.
	Cahir Town Centre Living-Working Quarter - The project will provide a dynamic town centre Square with a focus on pedestrian priority and civic space. Funding was approved in 2020 under the Rural Regeneration Development Fund. This category 2 project is completed. Total project costs approved are €986,354 and RRDF grant amounts to €663,362. Contractor to be appointed at end of January and commencement of demolition and enabling works to begin in February 2024.
	Carrick on Suir Regeneration Plan - Improvements will consist of public realm improvements; the provision of a new Enterprise and Digital Hub; the creation of an arrival point at Sean Healy Park from the Suir Blueway, public realm upgrade of Castle Street and repurposing of Ormond Castle Park as a high-quality Amenity and Biodiversity Park. Funding was announced by Minister Heather Humphreys under Phase 1 on 10th. November, 2022. Total project costs amount to €17,989,387. RRDF grant approved is €14,391,509. Phase 1 works to be complete in Q2 2024. Completion of tender documentation in Q1 2024 for detailed design works. Finalise design phase in Q1/Q2 2024 for Phase 4.

	Tipperary County Council has secured more funding than any other local authority in the country through the RRDF, with funding secured for various projects smaller towns and villages including Roscrea, Tipperary Town, Carrick-on-Suir, Templemore, Fethard, Kilsheelan (further detail of projects above).
	The development of Enhancement and Mobility Plans for the towns of Ballina / Killaloe and Newport further identify critical infrastructure projects to support the regeneration and growth of town and villages in the county.
	The Town Centre First Plan for Roscrea has been completed (September 2023), with the Plan already being utilised to develop funding bids through the Outdoor Recreation Infrastructure Scheme, Town and Village Renewal and RRDF. The Gantly Road Masterplan includes 5 phases, two of which have secured funding through the RRDF (new street and enabling infrastructure for the masterplan area) and a Town Centre Frist initiative run by the RIAI for innovative housing schemes.
	The 'Town Centre First Clonmel: Action Plan' was adopted by the elected members of the Clonmel MD in December 2022, and the Town team has been formed with meetings ongoing. Enhancement Plans for Newport, Mullinahone and Killenaule are being prepared to align with TCF principles.

The Council is working with the newly formed Carrick on Suir Town Team to prepare a new Town Centre First Plan for Carrick on Suir, utilising the template for Roscrea that has been endorsed by the Department for Housing.

The Council has held a number of workshops and advisory sessions in regional towns in the county, advising of the grant schemes available to home owners and prospective purchasers, that are funded by the Department for Housing, and other government departments and administered by the Council.

SICAP 2024-2028

The contract from the new Social Inclusion and Community Activation Programme (SICAP) for the 2024-2028 period was officially signed on 18th December at the Horse & Jockey by the Chairpersons of the Implementing Partners. The Social Inclusion and Community Activation Programme (SICAP) provides funding to tackle poverty and social inclusion at a local level through local engagement and partnerships between disadvantaged individuals, community organisations and public sector agencies.

<u>LECP</u>

Following adoption by the ESCP and the LCDC, the plan was adopted by Tipperary County Council on December 11th and submitted to the Minister's Office. The First Implementation Plan for the years 2024 and 2025 is near completion.

Leader Programme

The funding agreement for the LEADER 2023-2027 programme was signed after the December LCDC meeting. Funding will be available for projects in early 2024.

Community Enhancement Programme

180 projects were supported through small-scale operating and capital grants in 2023.

Clár Funding 2023

On 1st December 2023, the following 6 applications were announced as successful under Measure 1 Developing Community Facilities and Amenities of the 2023 Clár programme:

Local Enhancement Programme 2024 The Local Enhancement Programme 2024 capital fund will support groups, particularly in disadvantaged areas, to carry out necessary repairs and improvements their facilities, purchase equipment such as tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies and training equipment etc. This funding will help communities, community groups and committees, allowing them to continue to provide valuable services to the people in their area, and in the process strengthen the bonds that tie communities together. The fund also aims to support local strategic priorities through linkages with Local Economic Community Plans (LECPs). Ballingarrane

Tipperary County Council and the IDA have engaged RPS Group to prepare a planning application for a 100,000 sq ft Advanced Building Solution (ABS) in Precinct 3 in Ballingarrane Business and Technology Estate Park, Ballingarrane, Clonmel. The design will allow for all associated infrastructure including car parking, site services, landscaping and related works with additional lands adjoining the site to offer opportunities for expansion. The building will be designed to achieve LEED accreditation and NZEB compliance. The design is well in progress and it is expected planning will be lodged in Q2 of 2024. Stereame

In 2022, Mack Engineering, (specialists in design, fabrication and installation of steel structures) completed their new building and began operating from a 4-acre site in the business park. The company employs approximately 50 persons and continues to expand and develop. In 2023, Costa Coffee and McDonald's both opened stores in the estate (McDonald's utilises a refurbished unit that had been idle for 15 years), expanding footfall and movement in the area and supporting surrounding businesses and services.

Lisheen National Bio Economy Campus

The development of the Lisheen National Bio Economy Campus is supported in the RSES, TCDP and Thurles LAP. The Council is engaged with funding bodies, land owners, prospective developers in the

	development of a Masterplan for the site. Development is already taking place on the site. Revive Environmental has recently been granted permission to operate from the site and are actively developing the location. The Council is seeking funding through a number of different funding streams including EU Just Transition Funding to leverage and activate the National Bio Economy Campus.

	The TCDP was developed with Climate Action at its heart, with objectives and policies running throughout the Plan:

The TCDP includes targets to provide 600MW of operational wind energy and 150MW of operational solar energy by 2028. To date, the Council has supported a number of solar energy projects since the adoption of the TCDP but only 1 of these is operational over an area of 7.5ha, with a maximum capacity of 6.5MW. In total, there is almost 170MW of solar development with planning permission in Tipperary. The TCDP commits to reviewing the Council's Renewable Energy Strategy over the lifetime of the Plan.

A Centre of Excellence for Sustainable Energy, Nenagh - The proposal is to develop a Centre of Excellence for Sustainable Energy, to be the anchor and catalyst for the redevelopment of Martyr's Road Regeneration Quarter, a 10 ha. strategic site of brownfield lands and underutilised properties located in the heart of Nenagh Town Centre. The works to be supported also include Public Realm and Amenity Enhancement to Friar Street Civic Plaza, Martyr's Road Town Park, Martyr's Road streetscape improvements, including cycleways. Funding has been approved and the delivery and implementation of this project is ongoing.

Annual Energy and Farm Diversification Show –An annual Energy and Farm Diversification Show is held in Gurteen Agricultural College, in conjunction with Tipperary County Council. The show hosts over 100 speakers and attracts a national audience and ministers annually.

Renewable Energy and Smart Energy Communities – The Council continues to support community renewable energy initiatives such as the Templederry Wind farm.

Lisheen National Bio Economy Campus

The Council is engaged with funding bodies, land owners, prospective developers in the development of a Masterplan for the site. Development is already taking place on the site. Revive Environmental has recently been granted permission to operate from the site and are actively developing the location. The Council is seeking funding through a number of different funding streams including EU Just Transition Funding to leverage and activate the National Bio Economy Campus. The Council has ermitted bioenergy developments in the National Bioeconomy Campus and through the development of a masterplan for the National Bioeconomy Campus at Lisheen.

Fethard Town Park – This completed project consists of the development of a community sport and recreational campus, incorporating a community pavilion, playing pitches, walkways, parkland and open spaces. In 2024, the Council is seeking funding to further progress the development of improvement works along the Suir Blueway, design funding the development of the Lough Derg Greenway and funding for development of the Cahir Cashel greenway.

Newport Town Park – This park, covering an area of 9 acres, was opened in 2022 and cost €2.9m to deliver, funded through the Department of Housing, Limerick Hinterland Fund and TCC.

Littleton Labyrinth – This is a project to create a 23km trail around Ballynonty and Lough Dhoire Bhile. The project is a key aspect of Just Transition for the area, following the closure of the briquette factory in the area.

TCC, along with Kilkenny County Council, jointly manage the Local Authority Waters Programme (LAWPRO), a national shared service working on behalf of 31 local authorities in Ireland. LAWPRO works to achieve good or high-quality water quality in our rivers, lakes, transitional and coastal waters and groundwater as required by the EU Water Framework Directive,

In 2023, the following measures were undertaken by the Council:

- 724 samples were taken as part of Water Framework Directive (WFD) sampling programme
- 59 Section 4 monitoring samples were taken
- 74 farm inspections were performed

Clonmel

In 2023, Clonmel's Smart Skills for Farming Communities was named as the overall winner of the .ie Digital Town Awards 2023. This digital project helps famers use new technologies to make their work easier, save time and money as well as improving the sustainability and profitability of their farm.

The Council supports the development of a digital smart town centre by working with technology infrastructure providers to deliver high-spend broadband connectivity and facilities throughout the town centre. The Council supports the development of a further Digital Hub in the town centre (Objectives 4D and 4E of Draft Clonmel & Environs LAP 2024-2030).

Nenagh

The SECOE project is progressing to detailed design stage. 6 Architect-led design teams will be invited to tender in the coming months. The procurement of consultancy services will bring the project to construction and beyond, into the implementation phase of the project. The SECOE will be a national centre of excellence, for the development, research and implementation of SMART and innovative building technologies.

In Q1 2024, the Council will seek capital funding through the Smart Regions Enterprise Innovation Scheme for the development of the Rialto Digital & Enterprise Hub, Nenagh. Part 8 planning for the project was approved in January 2024. The project will provide a modern digital and enterprise hub facility using best practice and appropriate modern architectural intervention to provide excellent office, collaboration and meeting spaces.

Thurles

As provided for under the Thurles & Environs Draft LAP 2024-2030, it is proposed to develop a Digital Hub within the town. The Council is currently in the process of identifying a suitable location.

Carrick on Suir

The Regeneration Plan for the town will include the provision of a new Enterprise and Digital Hub. Capital funding has been approved through the RRDF.

Cahir

The Town Centre Regeneration Strategy will include the restoration and redevelopment of the vacant Cahir Market House and former Council Offices into a Business Development Centre which will be run by Cahir Development Association and provide offices, a large training and conference room, co-working spaces and hot desks to satisfy the unmet demand in the town. Capital funding has been approved through the RRDF.

Rural Communities

The (NBP) Broadband Connection Point Initiative will unlock the potential in of rural communities in County Tipperary. The (NBP) BCP delivery Programme is completed in County Tipperary and the following includes 21 Broadband Connection Points (BCPS) known as the "Tipperary BCP Network" which provide free public WiFi services to members of the public.

Section 6.5 (Education and Lifelong Learning) of the TCDP set out the third level education facilities in Tipperary which include the TUS campuses at Clonmel and Thurles; Mary Immaculate College (MIC, St Patricks College) at Thurles; the agricultural college at Gurteen, along with the Tipperary Education and Training Board (ETB).
Funding has been secured for the Sustainable Energy Centre of Ireland (SECOE) in Nenagh and the project management plan for the delivery and implementation of this project is ongoing. The projects include research and educational space, and is supported by TUS as one of the project delivery partners.
Thurles is being promoted as a Third Level Town and policy support is provided under the Draft Thurles & Environs LAP 2024-2030 (Objective 5C and 5D). Mary Immaculate College have published a 20-year plan for growth which includes for a significant expansion of their Thurles campus.
The development of the National Bioeconomy Campus at Lisheen, Thurles is subject of a Masterplan. Policy support is provided in the Draft Thurles & Environs LAP 2024-2030 (Objective 4B) and the TCDP 2022-2028 (Objective 10-D).
The Council continues to work with TUS and the ETB to deliver a co-located third and further education campus facility on Kickham Barracks, Clonmel. In particular, the Council shall facilitate TUS Clonmel to re-locate from their current location on Frank Drohan Road to the new co-located campus facility in Kickham Barracks (Objective 5E of the Draft Clonmel & Environs LAP 2024-2030).
