3. Presentation on a Smart Region Framework for the Southern Region

David Kelly set the context for the Smart Region Framework and the Learning Region outlining that they are both important and linked strands in the implementation of the RSES. He introduced Dr Niall Connolly, Associate Professor in Innovation & Entrepreneurship, Maynooth University, Vice-Chair All-Ireland Smart City Forum who gave a presentation (copy available) on the Smart Region Framework for the Southern Region.

A discussion followed with contributions from the Cathaoirleach, Cllr. Boyle, Cllr. Forde, Cllr. Kelly, Cllr. McCarthy and Cllr. Phelan. Key issues discussed included:

- The need for interaction between local authorities;
- Learning lessons and good practice from other countries;
- How the framework can assist local authorises in defining and implementing a "Smart Region";
- The need for the framework to be flexible enough to allow for the variances across the region.

Bryan Riney gave a presentation on "Towards a Learning Region". A discussion followed with contributions from Cathaoirleach, Cllr. Kinsella, Cllr. Kelly, Cllr. Phelan, Cllr. McCarthy, Cllr. Brennan, Cllr O' Brien, Cllr. G Murphy and Cllr. Boyle.
