1. Please provide an overview of progress in Securing the actions relevant to the RSES of Our Rural Future Rural Development Policy 2021 – 2025 as they apply to the Southern Region.

Our Rural Future is the whole-of-Government's policy for balanced, sustainable, regional development. It advocates a bottom-up approach, to address the needs and wants of rural communities around the country, including the Southern Region, to ensure that rural towns and villages are attractive places to live, work and study. There are more than 170 measures contained in the policy, each of which is assigned to a government department or agency for delivery. Since its publication in 2021, Our Rural Future has reported the status of measures, and incorporated new measures and actions, in a series of six-monthly Progress Reports and annual Work Programmes. 2. Development of the local link Rural Transport and other sustainable transport options

The Department of Transport (Local Link), Department of Education (School transport) and Department of the Environment, Climate and Communications (Sustainable/Active transport) hold the responsibility for the majority of rural transport and transport infrastructure. Under Our Rural Future, the measures for delivery assigned to these departments are monitored for implementation, and updates are published in a series of six-monthly Progress Reports and annual Work Programmes, which can be viewed on the DRCD website: <https://www.gov.ie/en/collection/bcbca-our-rural-future-annual-work-programmes-and-progress-reports/>

(Ref: RPO 83 :Island and Coastal Communities)DRCD continues to invest in sustainable developments and upgrade of island infrastructures through its minor capital works programme. Island specific capital funding is made available to Local Authorities to upgrade facilities. DRCD continues to subsidise affordable, reliable, year round ferry and cargo services for the island communities to enhance the sustainability of our off-shore islands.

3. Please outline any progress made by agencies that operate under the aegis of your Department, in supporting the objectives of the RSES which are relevant to that agency

The Western Development Commission (WDC) is a statutory body that was set up to promote both social and economic development in the Western Region. It supports the delivery of Government policy towards balanced regional development across a wide variety of sectors including its work on the AEC initiative.

The Atlantic Economic Corridor (AEC) is the term applied to the linear network along the Western seaboard, stretching from Kerry to Donegal. The overarching objective of the AEC initiative is to maximise assets along the western seaboard in order to attract investment, support job creation and contribute to an improved quality of life for those who live there. The initiative has the potential to act as a key enabler for the regional growth objectives of the National Planning Framework.

The AEC initiative has to date enabled a number of projects to be developed, most notably the AEC Hub Network project, which has since progressed to a national initiative in the form of Connected Hubs. Connected Hubs, a Government of Ireland initiative launched in May 2021, is a single network of remote working facilities that provides users with information on, and the location of facilities available at remote working hubs throughout Ireland. It has grown substantially since its launch and now has c.340 hubs live on its online booking platform (www.connectedhubs.ie). Ultimately ConnectedHubs.ie will link over 400 hubs nationally.

Together with a booking platform and nationwide scope, Connected Hubs also enables small rural hubs to avail of a centralised billing system and applications to support hub management tasks. It has also helped bring together rural hub teams, who previously worked alone and unsupported. By providing a professional remote working space, many rural hubs also enable holiday makers extend their time away during the summer/Easter/Christmas breaks. Through extending the tourist season, local community members and businesses in the area also benefit.

4. Please provide details of any policy initiatives/developments that have been finalised or are in preparatory stages that support the objectives of the RSES

Our most recent Statement of Strategy was published in August 2023, and this sets out the Department's mission as “to promote and support vibrant, inclusive and sustainable communities throughout Ireland”. The Department has two overarching policies which support delivery of this mission, firstly, *Our Rural Future* the Government's Rural Development Policy for 2021-2025, and secondly *Sustainable Inclusive and Empowered Communities*, the 5 year strategy (for the period 2019-2024) to support the community and voluntary sector in Ireland.

The very successful ongoing implementation of *Our Rural Future* in 2023 has been a significant achievement of the Department. The rural development investment programme continues to support investment throughout rural Ireland by delivering schemes including the Rural Regeneration and Development Fund, the LEADER Programme, Town and Village Renewal, the Outdoor Recreation Infrastructure Scheme and the CLÁR Programme. Furthermore, policies and strategies which form part of *Our Rural Future*, including the Towns Centre First Strategy and the National Outdoor Recreation Strategy continue to be successfully implemented.

The new national islands policy, *Our Living Islands*, was published in June 2023. It is the first whole-of-Government policy for the islands to be published in 27 years. It is an ambitious ten year national policy designed to support sustainable island communities and is accompanied by an Action Plan for the period 2023-2026. The Action Plan consists of 80 new time-bound actions agreed with and to be implemented by various stakeholders, led by a nominated Government Department or State Agency.

Community Policy

In order to create a vibrant, sustainable and inclusive society, communities need to be empowered to develop and sustain their own wellbeing.

In August 2019, the Minister for Rural and Community Development launched Sustainable, Inclusive and Empowered Communities; A five-year strategy to support the community and voluntary sector in Ireland. The strategy was co-produced by Government and people from the community development, local development, community and voluntary and local government sectors through a Cross Sectoral Group (CSG).

In order to support the Department’s mission to “promote rural and community development and to support vibrant, inclusive and sustainable communities throughout Ireland” the Strategy seeks to use a mix of policy initiatives and funding supports for communities, non-profit organisations and the community and voluntary sector, while also working with other Government Departments and agencies that support communities.

The Strategy sets a general direction of travel for government policy in relation to the community development, local development and the community and voluntary sectors for the coming decade.

Values and Principles

One of the key achievements of the five-year Strategy to support the Community and Voluntary Sector was the agreement of a set of clearly defined, shared Values and Principles, which guided the strategy’s development and form the basis for collaboration and partnership working in the pursuit of the best outcomes achievable.

The adoption of these values and principles fulfils Action 1.2 in the strategy: Adopt an agreed set of values and principles for collaboration and ‘partnership-working’ at national and local level.

The Values and Principles were agreed by Government and adopted on a whole of government basis in May 2022 and formally launched by Minister of State for Community Development and Charities, Joe O’Brien TD, on 19 October 2022.

These Values and Principles will be used by all Government Departments and Agencies as a basis for their interaction with the Community and Voluntary Sector.

Participation of Marginalised Communities in Decision-Making Structures

This was a Dormant Accounts Funded project that built capacity, as well as providing resources and toolkits to support the engagement of marginalised communities in consultation and decision-making processes at local level. An updated resource guide, entitled ‘A Guide for Inclusive Community Engagement in Local Planning and Decision Making – Version 2’ was launched by Minister of State Joe O’Brien on 25 October 2023. A showcase event was held at the above launch in Dublin with presentations from three LCDC led pilot programmes of Clare, Wicklow and Galway City. There were also presentations from LGBT Ireland, NASC and IHREC along with panel and group discussions on the day. As part of the project training has been delivered to local authorities and related stakeholders on inclusive engagement, intercultural awareness, the Public Sector Duty and in facilitation skills. A series of training videos to work in tandem with the guide are currently being finalised and will be released in early 2024.

LECP

DRCD in conjunction with the Department of Housing, Local Government and Heritage and an LECP Advisory Group developed LECP guidelines which were published in 2021.

The aim of the guidelines is to provide support to Local Authorities and relevant local partners to help them to develop and implement comprehensive and flexible 6-year plans that will support the sustainable development of their areas over the lifetime of the plan. The plans will form the basis for interventions at a local level that are complementary to and consistent with the RSES, the City and County Development Plans and the relevant national strategies and policies listed in Appendix 6 of said Guidelines. Some LECPs are finalised and most local authorities are now getting approval of the final drafts through the Municipal Districts, SPCs and LCDCs and final approval by the full councils.

DRCD also hosted a series of training webinars in 2022 to ensure that each LCDC has the necessary knowledge and skills to develop and implement their LECPs. One LECP support Webinar focussed on Economic/Infrastructure/Local Enterprise including spatial planning and public infrastructure – urban and rural, green and recreational spaces and sectoral/enterprise strategies (including social enterprise).

The Social Inclusion and Community Activation Programme (SICAP)

SICAP addresses high and persistent levels of deprivation through targeted and innovative, locally-led approaches. It supports in need groups and communities and individuals including unemployed people, people living in deprived areas, people with disabilities, single parent families, people on a low income and members of the Traveller and Roma community. This type of support will continue over the lifetime of the current programme, which runs from 2018 to 2023.

The procurement for the next iteration of SICAP 2024-2028 is currently ongoing. Of the 53 SICAP Contract Areas, 48 have completed procurement and signed contracts for programme delivery. Extensions to the current SICAP programme have been granted in the remaining areas, to allow for the procurement process to conclude whilst also ensuring continuation of SICAP services.

In 2023 SICAP supported over 2,797 Local community groups & 32,563 individuals.

Town Centre First (TCF):

The TCF policy provides a coordinated, whole-of-government policy framework to proactively address the decline in the health of towns across Ireland and support measures to regenerate and revitalise them. This policy was co-created by the Department of Rural & Community Development and the Department of Housing, Local Government and Heritage. The implementation of the policy is underpinned by schemes such as the Rural Regeneration and Development Fund (RRDF), the Urban Regeneration and Development Fund (URDF), the Croí Conaithe (Towns) Fund and the Town and Village Renewal Scheme (TVRS).

Key elements of the policy include the establishment of the National TCF Office, the appointment of Town Regeneration officers in eligible rural Local Authorities and the completion of TCF Plans.

A Town Regeneration Officer has been appointed in each county within the Southern Regional Assembly's remit.

A TCF plan reimagines the potential of an individual town, focusing in particular on its town centre and immediate surroundings and identifies potential future projects in the area. TCF plans were completed in the following counties within the Southern Regional Assembly’s remit:

All 26 pilot plans have now been completed. The Department is currently making preparations to implement further supports under the TCF policy and are expected to be announced in January 2024. Regarding TCF plans, it is expected that a similar approach will be taken where one town from each county will be selected to complete a plan.

The Community Volunteer Programme

The Community Volunteer Programme, introduced in the National Volunteering Strategy 2021 – 2025 and supported by the Resilience and Recovery 2020-2021 Plan for Living with COVID-19, is a measure to build on existing volunteering capacity to meet future, intermittent needs and to provide for future events.

Community Volunteers are fully trained in Urgent Support response through the national network of Volunteer Centres and can support Local Authorities, the Civil Defence, the Red Cross and other Blue Light organisations when extreme weather events occur.

Community Volunteers are a national team of volunteers who already have experience volunteering together in their local community. They can be engaged quickly and have the willingness and availability to assist in their community when extreme weather events occur. These volunteers are an essential resource for our local communities when short term urgent support is required, by providing an invaluable service, without cost, to supplement the emergency services in their roles.

LEADER

The LEADER Programme is a key intervention of Our Rural Future, the Government’s Policy for rural development which aims to deliver a range of actions to rural communities over the lifetime of the policy. The LEADER programme supports private enterprises and community groups who improve the quality of life and economic activity in rural areas through a CLLD (Community-Led Local Development) approach. Under the 2014-2022 LEADER Programme this support was provided to projects under the following themes:

- Economic Development, Enterprise Development and Job Creation
- Social Inclusion

- Rural Environment

Under the 2023-2027 LEADER Programme there will also be a requirement for the Smart Villages concept, climate change mitigation and adaptation and the Sustainable Development Goals (SDGs) to be over-arching elements of LEADER Interventions.

The 2023-2027 LEADER programme will support a broad range of activities which aim to respond to the diversity of the local needs of our rural areas. Projects will be supported under the key themes of:
