The population of the County grew by 5% to 104,160. This is an increase of 4,928 persons between 2016 & 2022.

The population of Kilkenny City was 27,184 in 2022. In 2016 the population of the City was 26,512. This is an increase of 672 persons in that period

Under the NPF the growth strategy identified a population of 110,00 & 29,822 for the County & City respectively.

The Council has an active land management policy which looks at the availability of zoned land and encourages land owners to release land particularly for housing through the operation of the Vacant Sites Levy and the Derelict Sites Act.

To date over 20 sites have been activated through the Vacant sites levy.

The Council continues to develop its flagship regeneration project of the Abbey Quarter in Kilkenny City. In Q2 tenders will be sought for the development of the urban park surrounding the St Francis Abbey along with delivery of the main street in the regeneration lands.

approval (February 2022) of an grant to the amounts of €250,000, with total project cost €277,500.

Department's requirements on approving the grant was that the Council would purchase and own the building and subsequently lease to UTT and subsequently Kilkenny County Council purchased the building in April 2022.

Opening in Spring 2024, the hub (Exit 4), located in Urlingford will provide fully serviced and expertly managed office spaces that cater to various users seeking a balance between shared office environments and individual privacy. It will serve as a destination for businesses, organisations, or agencies in search of a centrally located venue for conferences or training sessions.

Connected Hubs

There are now 10 remote or co working hubs located throughout the county. September 2023 saw the launch of a radio, paper and digital marketing campaign to promote the number of community and privately-owned remote working hub spaces in Kilkenny. The 'more than just a desk' campaign promotes the available desks, it promotes the quality of life in Kilkenny as a location to work. The Connected Hubs in Kilkenny include locations in Galmoy, Glenmore, Ballyousskill, Crosspatrick and Dunbell and were launched in May 2022. <https://belongkilkenny.ie/careers-kilkenny/remote-working-hubs/>

South East Greenway

The initial 6km between New Ross and Glenmore was officially unveiled in July 2023. South East Greenway. When fully completed the amenity will link New Ross in Co Wexford to Waterford city, with most of the 24km track in South Kilkenny.

The works contract for the next phase of the Greenway a 5.5km section from Ferrybank to Curraghmore, was awarded in Q4 2023 and works there are ongoing.

The design of the remainder of the 24km greenway is continuing and will be completed in 2025.

Freshford Playground.

In June 2023 a new playground which extends to just under one acre and includes a zip-wire, swings, slides, play tower, basket swing and woodland play equipment along with a new access road and carparking area to service the amenity. The site also caters for a new wildflower meadow and additional tree planting all of which will help to combat the decline of pollinators.

The completed project, located beside St Lachtain's GAA Club and national school, sees an investment of over €240,000 into Freshford village, made up of a combination of funding streams

Dunmore Bio diversity park

A former Kilkenny landfill site has been given a new lease of life and turned into a bio diversity park.

The former municipal landfill at Dunmore has been transformed into a new countryside park. It occupies an area of circa. 24 acres and is located just 5km north of Kilkenny city centre.

It offers the public access into the countryside with three themed trails to walk and includes a dog friendly enclosure.

Slieverue park

A new amenity space, located at the northern end of the village of Slieverue, was delivered under two phases. Under Phase One works commenced back in 2021 having secured funding under the Town and Village Renewal Scheme whilst Phase Two commenced in 2022 and was completed in 2023. It was opened to the public in June 2023.

Amenity Projects

The Project Office & Parks Department oversees the development and maintenance of a wide variety of outdoor recreational amenities in Kilkenny city and county, including playgrounds, parks, walking trails, multi-use game areas and sports pitches, which are available for use to people of all ages. The Project Office & Parks Department also manage grass cutting, pollinator and biodiversity projects, tree surgery and the day-to-day upkeep of parks and playgrounds.

The total number of playgrounds maintained by the Project Office & Parks Department is now 33.

Outdoor Recreational Infrastructure Scheme (ORIS)

Under ORIS Measure 1, a total of 7 no. projects, were completed in 2023. The projects included:

Digital Strategy 2024 to 2026

The Council have commenced the preparation of a Digital Strategy. It will be a three-year plan outlining Kilkenny County Council’s strategic goals and objectives for the period 2024 - 2026. The strategy will set out an overall vision including a number of core objectives and outline a clear path for implementation. It will look to capitalise on digital technologies and infrastructure to benefit the staff of Kilkenny County Council and the citizens of Kilkenny City and County. The Digital Strategy will include four pillars – (1) Digital Infrastructure, (2) Digital Skills (3) Digital Transformation of Business and (4) Digitalisation of Public Services. There will be key strategic objectives and actions set out under each of these pillars.
